AN ORDINANCE CONCERNING

Building, Fire, and Related Codes – ~~2012~~ 2013 Edition

FOR the purpose of adopting a revised Building, Fire, and Related Codes Article, comprising the Maryland Building Performance Standards (effective January 1, 2012), the International Building Code (2012 Edition), the International Electrical Code (2011 Edition), the International Fuel Gas Code (2012 Edition), the International Mechanical Code (2012 Edition), the International Plumbing Code (2012 Edition), the International Property Maintenance Code (2012 Edition), the International Fire Code (2012 Edition), the International Energy Conservation Code (2012 Edition), and the International Residential Code for One- and Two-Family Dwellings (2012 Edition), all as supplemented, amended, or otherwise modified by this Ordinance; providing for the effect, construction, and effective date of these new standards and codes; conforming, correcting, and clarifying certain language; and generally relating to the adoption of new building, fire, property maintenance, electrical, plumbing, mechanical, and related codes for Baltimore City.

SECTION 1. BE IT ORDAINED BY THE MAYOR AND CITY COUNCIL OF BALTIMORE, That Part IV {"National Fuel Gas Code"} and Part VI {"National Standard Plumbing Code"} of the Building, Fire, and Related Codes Article of the City Code are repealed.

SECTION 2. AND BE IT FURTHER ORDAINED, That the Laws of Baltimore City read as follows:

Baltimore City Revised Code

Article – Building, Fire, and Related Codes

Part I. Maryland Building Performance Standards

§ 1-101. State action.

(a) In general.

The Maryland Building Performance Standards are adopted and, from time to time, amended by the State Department of Housing and Community Development under State Public Safety Article, Title 12, Subtitle 5.

(b) Contents.

As amended effective January 1, [2010] 2012, these Standards consist of:

- (1) the International Building Code [(2009 Edition)] (2012 EDITION), with certain State modifications {COMAR 05.02.07.04A and B};
(2) the International Residential Code for One- and Two-Family Dwellings [(2009 Edition)] (2012 EDITION), with certain State modifications {COMAR 05.02.07.04A and C}; and
(3) the International Energy Conservation Code [(2009 Edition)] (2012 EDITION), with certain State modifications {COMAR 05.02.07.04A and D}.

§ 1-102. City adoption.

The Maryland Building Performance Standards are adopted as part of the Building, Fire, and Related Codes of Baltimore City, subject to the following modifications:

- (1) in the International Building Code [(2009 Edition)] (2012 EDITION):
(i) incorporate the State modifications indicated in the appropriate chapter, section, or other provision of Part II below; and
(ii) add the Baltimore City modifications indicated in the appropriate chapter, section, or other provision of Part II below;
(2) in the International Residential Code for One- and Two-Family Dwellings [(2009 Edition)] (2012 EDITION):

7 section, or other provision of [Part IX] PARTS IX-A AND IX-B below; and

8 (ii) add the Baltimore City modifications indicated in the appropriate chapter,
9 section, or other provision of [Part IX] PARTS IX-A AND IX-B below.

10 Part II. International Building Code

11 § 2-101. City adoption.

12 (a) *In general.*

13 The International Building Code [(2009 Edition)] (2012 EDITION) is adopted as part of
14 the Building, Fire, and Related Codes of Baltimore City, subject to the additions,
15 deletions, amendments, and other modifications contained in this Part II.

16 (b) *Codification.*

17 Unless otherwise specified, chapter and section numbers in this Part II refer to the chapter
18 and section numbers of the International Building Code.

19 § 2-102. Maryland Building Performance Standards.

20 The Maryland Building Performance Standards contain certain State modifications to the
21 International Building Code. The State modifications that Baltimore City has adopted are
22 repeated in this Part II, for the user's convenience, in the appropriate chapter, section, or
23 other provision. These State modifications are labeled "MBPS Modification".

24 § 2-103. City modifications.

25 The additions, deletions, amendments, and other modifications adopted by the City are as
26 follows:

27 Chapter 1. SCOPE AND Administration

28 {**MBPS Modification** – Note to Chapter 1: Local jurisdictions are responsible for the
29 implementation and enforcement of the Maryland Building Performance Standards. Refer to
30 each local jurisdiction for local amendments to Chapter 1 of the IBC. Each local jurisdiction
31 having authority shall establish ... implementation and enforcement procedures that include:
32 (a) review and acceptance of appropriate plans; (b) issuance of building permits; (c) inspection
33 of the work authorized by the building permits; and (d) issuance of use and occupancy
34 certificates.}

1 Section 101 General

2 **101.1 Title.** THE REGULATIONS CONTAINED IN THIS CODE CONSTITUTE AND ARE KNOWN AS THE
3 “BALTIMORE CITY BUILDING CODE”. The [International] BALTIMORE CITY Building Code, together
4 with the standards and codes listed in § 101.4 {“REFERENCED CODE”} OF THIS CHAPTER, as
5 supplemented, amended, or otherwise modified by these provisions, collectively constitute and are
6 known as the “Building, Fire, and Related Codes of Baltimore City”.

7 **101.1.1 References to “this Code”.** Throughout [these provisions] THIS PART II [and the
8 standards and codes listed in § 101.4], all references to “this Code” refer to the Building, Fire,
9 and Related Codes of Baltimore City.

10 **101.2 Scope. {As in IBC}**

11 **Exception 1: [{As in IBC Exception}] {PER MBPS MODIFICATION}** DETACHED 1- AND
12 2-FAMILY DWELLINGS AND MULTIPLE SINGLE-FAMILY DWELLINGS (TOWNHOUSES) NOT MORE
13 THAN 3 STORIES ABOVE GRADE PLANE IN HEIGHT WITH A SEPARATE MEANS OF EGRESS AND
14 THEIR ACCESSORY STRUCTURES MUST COMPLY WITH THE INTERNATIONAL RESIDENTIAL
15 CODE.

16 **Exception 2: {Per MBPS Modification}** Existing buildings undergoing repair, alterations,
17 or additions, and change of occupancy must comply with the Maryland Building
18 Rehabilitation Code, set forth in COMAR 05.16.

19 **101.2.1 Appendices {Per MBPS Modification}.** The appendices to the International Building
20 Code apply as follows:

21 **101.2.1.1 Appendices adopted.** The provisions of the following appendices are adopted as
22 part of this Code:

- 23 1. Appendix C: “Group U – Agricultural Buildings”.
- 24 2. Appendix D: “Downtown Fire District”.
- 25 3. Appendix F: “Rodent Proofing”.

30 **101.2.1.2 Appendices not adopted.** The following appendices are not adopted as part of
31 this Code:

4 **101.3 Intent.** *{As in IBC}*

5 **101.4 Referenced Codes.** The standards and codes listed in this § 101.4, as modified by these
6 provisions and as referred to elsewhere in this Code, are part of the requirements of this Code to the
7 extent prescribed by the reference.

8 **101.4.1 Electrical.** The National Electrical Code [(2008 Edition)] (2011 EDITION), AS MODIFIED
9 IN PART III OF THIS CODE, applies to the installation of electrical systems, including their
10 alteration, repair, replacement, equipment, appliances, fixtures, fittings, and appurtenances.

11 **101.4.2 Gas.** The [National] INTERNATIONAL Fuel Gas Code [(2009 Edition)] (2012 EDITION),
12 AS MODIFIED IN PART IV OF THIS CODE, applies to the installation of gas piping from the point of
13 delivery, to gas appliances, and to related accessories as covered in this Code. These
14 requirements apply to gas piping systems extending from the point of delivery to the inlet
15 connections of appliances and the installation and operation of residential and commercial gas
16 appliances, and related accessories.

17 **101.4.3 Mechanical.** *{As in IBC}* THE INTERNATIONAL MECHANICAL CODE (2012 EDITION),
18 AS MODIFIED IN PART V OF THIS CODE, APPLIES TO THE INSTALLATION, ALTERATIONS, REPAIRS,
19 AND REPLACEMENT OF MECHANICAL SYSTEMS, INCLUDING EQUIPMENT, APPLIANCES, FIXTURES,
20 FITTINGS, AND APPURTENANCES, INCLUDING VENTILATING, HEATING, COOLING, AIR-
21 CONDITIONING AND REFRIGERATION SYSTEMS, INCINERATORS, AND OTHER ENERGY-RELATED
22 SYSTEMS.

23 **101.4.4 Plumbing.** The [National Standard] INTERNATIONAL Plumbing Code [(2009 Edition)]
24 (2012 EDITION), AS MODIFIED IN PART VI OF THIS CODE, applies to the [erection,] installation,
25 alteration, repair, [relocation,] AND replacement, use, or maintenance of or addition to plumbing
26 systems, including equipment, appliances, fixtures, fittings, and APPURTENANCES.

27 **101.4.5 Property maintenance.** *{As in IBC}* THE INTERNATIONAL PROPERTY MAINTENANCE
28 CODE (2012 EDITION), AS MODIFIED IN PART VII OF THIS CODE, APPLIES TO EXISTING
29 STRUCTURES AND PREMISES; EQUIPMENT AND FACILITIES; LIGHT, VENTILATION, SPACE HEATING,
30 SANITATION, LIFE, AND FIRE SAFETY HAZARDS; RESPONSIBILITIES OF OWNERS, OPERATORS, AND
31 OCCUPANTS; AND OCCUPANCY OF EXISTING PREMISES AND STRUCTURES.

32 **101.4.6 Fire prevention.** *{As in IBC}* THE INTERNATIONAL FIRE CODE (2012 EDITION), AS
33 MODIFIED IN PART VIII OF THIS CODE, APPLIES TO MATTERS AFFECTING OR RELATING TO
34 PREVENTION OF STRUCTURES, PROCESSES, AND PREMISES FROM THE HAZARD OF FIRE AND
35 EXPLOSION ARISING FROM THE STORAGE, HANDLING OR USE OF STRUCTURES, MATERIALS, OR
36 DEVICES; FROM CONDITIONS HAZARDOUS TO LIFE, PROPERTY, OR PUBLIC WELFARE IN THE
37 OCCUPANCY OF STRUCTURES OR PREMISES; AND FROM THE CONSTRUCTION, EXTENSION, REPAIR,
38 ALTERATION OR REMOVAL OF FIRE SUPPRESSION, AUTOMATIC SPRINKLER SYSTEMS AND ALARM
39 SYSTEMS OR FIRE HAZARDS IN THE STRUCTURE OR ON THE PREMISES FROM OCCUPANCY OR
40 OPERATION.

41 **101.4.7 Energy.** *{As in IBC}* THE INTERNATIONAL ENERGY CONSERVATION CODE (2012
42 EDITION), AS MODIFIED IN PARTS IX-A AND IX-B OF THIS CODE, APPLIES TO ALL MATTERS
43 GOVERNING THE DESIGN AND CONSTRUCTION OF BUILDINGS FOR ENERGY EFFICIENCY.

1 [101.5 **State Rehabilitation Code.** The Maryland Rehabilitation Code, adopted under State Code
2 Article 83B, § 6-503, and codified in COMAR 05.16, applies to all rehabilitation projects undertaken
3 in existing buildings, as provided in that Code.]

4 **101.5 [101.6] References to former Codes.** All references in a violation, [or] condemnation, OR
5 OTHER notice, IN A CITATION, or in the Baltimore City Code to any former version of the Building
6 Code or to any provision of that Code are considered to refer to the comparable or otherwise
7 applicable provisions of this Code.

8 **Section 102 Applicability**

9 **102.1 to 102.5** *{As in IBC}*

10 **102.6 Existing conditions.** Conditions lawfully existing on the effective date of this Code may be
11 continued without change, except as:

- 12 1. specifically provided by this Code (including the standards and codes incorporated in it), or
- 13 2. deemed necessary by the Building Official for the general safety and welfare of the
14 occupants and the public.

15 **102.7 Structures owned by City.** This Code does not apply to any structure (other than a building)
16 that is owned by the City, to the extent that the structure:

- 17 1. is located on, over, or under a street, alley, or other public way or land, and
- 18 2. is designed, constructed, controlled, and maintained by and under the authority and
19 supervision of the Director of Public Works OR THE DIRECTOR OF GENERAL SERVICES,
20 WHICHEVER HAS JURISDICTION, or an authorized representative of the Director.

21 **102.8 Public service structures on streets.** This Code does not apply to any pole, conduit, tunnel,
22 pipe line, manhole, or other similar surface or subsurface structure, including its equipment, that is
23 owned and controlled by a public service corporation, to the extent that:

- 24 1. the structure is located on, over, or under a street, alley, or other public way or land,
- 25 2. its construction is authorized by the City, and
- 26 3. its installation is regulated and supervised by the Director of Public Works, THE DIRECTOR
27 OF GENERAL SERVICES, OR THE DIRECTOR OF TRANSPORTATION, WHICHEVER HAS
28 JURISDICTION, or an authorized representative of the Director.

29 **102.9 Property owned or leased by United States or by Maryland.** Except as specified in
30 § 102.9.1, land owned by the United States or by the State of Maryland, including any structure
31 owned by either and located on the land, is exempt from this Code.

32 **102.9.1 Exceptions.** The following are not exempt from this Code:

- 33 1. land or structures leased by the United States or the State of Maryland from a private
34 owner,
- 35 2. land or structures leased by a private owner from the United States or the State of
36 Maryland, and

- 1 3. land or structures held by the United States or the State of Maryland pursuant to the
2 foreclosure of a residential mortgage.

3 **102.10 Waterways.** Other than work done by the United States or the State of Maryland, all
4 construction done along the shoreline and waterways within the City must:

- 5 1. comply with this Code, and
6 2. be approved by:
7 a. the Department of Public Works,
8 b. the Department of General Services,
9 c. the Department of Planning,
10 d. the Fire Department,
11 e.. the Maryland Department of the Environment, and
12 f.. the U.S. Army Corps of Engineers.

13 **102.11 Railroad facilities.** Railroad facilities within a railroad right-of-way are exempt from the
14 provisions of this Code, except for those provisions that relate to sanitary maintenance. However,
15 privately owned structures within a right-of-way are not exempt unless they are ancillary to the
16 railroad.

17 **102.12 Moved structures.** Structures that are moved into or within Baltimore City:

- 18 1. must comply with the provisions of this Code for new structures, and
19 2. may not be used or occupied, in whole or in part, until the Building Official approves an
20 occupancy permit for the structure.

21 **102.13 to 102.14 {Reserved}**

22 **102.15 Compliance with Code required.** No structure, premises, land, or equipment may be
23 constructed, altered, added to, repaired, rehabilitated, demolished, moved, located, used, occupied,
24 or maintained in violation of this Code.

25 **102.15.1 Construction of structure.** When constructed, every structure must be located so that
26 it does not create a violation of this Code.

27 **102.15.2 Relocation, etc., of lot lines, etc.** No lot or property line may be moved or relocated
28 and no lot or parcel of land may be subdivided in any way that creates a violation of this Code
29 for any structure.

30 **102.16 Compliance with other laws.** To the extent applicable, all work must also comply with:

- 31 1. the Critical Area Management Program of Baltimore City,
32 2. the Baltimore City Forest and Tree Conservation Program,
33 3. THE BALTIMORE CITY SUSTAINABILTY PLAN,

- 1 4 3. the Zoning Code of Baltimore City,
2 5 4. City Code Article 6 {"Historical and Architectural Preservation"},
3 6 5. any applicable Urban Renewal Plan,
4 7 6. the Department of Public Works rules and regulations governing:
5 a. storm water management,
6 b. soil erosion and sediment control, and
7 c. discharges to the storm drain system,
8 8 7. the Department of General Services rules and regulations governing:
9 a. encroachments into the public right-of-way,
10 b. developer's agreements, and
11 c. blasting,
12 9 8. the Federal Americans with Disabilities Act,
13 10 9. the Maryland Accessibility Code, and
14 11 10. all other applicable laws, RULES, AND REGULATIONS of the United States, the State of
15 Maryland, and the City of Baltimore.

16 **Section 103 Department of Building Safety**

17 **103.1 Enforcement agency.** This Code is administered and enforced by the BALTIMORE CITY
18 Department of Housing and Community Development and its Commissioner. Accordingly, in this
19 Code:

- 20 1. "Department of Building Safety" or "Department" means the BALTIMORE CITY Department
21 of Housing and Community Development, and
22 2. "Building Official", means the Commissioner of Housing and Community Development or
23 an authorized representative of the Commissioner.

24 **103.2 Appointment.** *{Not Adopted}*

25 **103.3 Deputies.** *{Not Adopted}*

26 **103.4 Employee restrictions.** An officer or employee of the Department may not:

- 27 1. engage in or directly or indirectly be connected with the furnishing of labor, materials, or
28 appliances or the preparation of plans or specifications for the construction, alteration,
29 addition, repair, rehabilitation, demolition, moving, or maintenance of a structure, unless the
30 officer or employee is the owner of the structure, or
31 2. engage in any work that conflicts with his or her official duties or with the interests of the
32 Department.

1 Section 104 Duties and Powers of Building Official

2 **104.1 General.** Except as otherwise specifically provided by law, the Building Official:

- 3 1. administers and enforces all provisions of this Code and the provisions of all other
4 ordinances, laws, or regulations relating to the matters provided for in this Code, and
- 5 2. may act on any question relative to the manner of and the materials to be used in
6 the construction, alteration, addition, repair, rehabilitation, demolition, moving, location,
7 use, occupancy, and maintenance of all structures and in the installation of equipment.

8 **104.1.1 Interpretations, rules, and regulations.** The Building Official may:

- 9 1. render interpretations of this Code, and
- 10 2. adopt rules and regulations to carry out this Code.

11 **104.1.2 Filing rules and regulations.** A copy of all rules and regulations adopted under this
12 Code must be filed with the Department of Legislative Reference.

13 **104.2 to 104.5** *{As in IBC}*

14 **104.6 Right of entry.** In the performance of his or her duties, the Building Official may enter any
15 land, structure, or premises in the City to enforce this Code, at any reasonable time or, in an
16 emergency that might endanger public health or safety, at any time.

17 **104.6.1 Entry without notice or warrant.** Neither a search warrant nor prior notice is needed
18 in any of the following circumstances:

- 19 1. if entry is by permission or at the request of an occupant of the land, structure, or
20 premises or a person with apparent right of possession,
- 21 2. if the land, structure, or premises is open and accessible to members of the general
22 public,
- 23 3. if the Building Official reasonably believes that an imminent danger to health or safety
24 exists or might exist, or
- 25 4. immediately after an accident or disaster that causes the Building Official to believe that
26 immediate entry is necessary for investigative purposes or to protect property or public
27 health or safety.

28 **104.6.2 Authority to seek warrant.** Where appropriate, the Building Official may seek a
29 search warrant to enter any land, structure, or premises in the City to make an inspection or to
30 take any other authorized action to administer and enforce:

- 31 1. this Code (including the standards and codes incorporated in it), or
- 32 2. any of the following (collectively “related laws”):
 - 33 a. the Health Code of Baltimore City,
 - 34 b. the Zoning Code of Baltimore City,

- 1 c. an Urban Renewal Plan,
- 2 d. City Code Article 6 {"Historical and Architectural Preservation"}, or
- 3 e. any other related statute, ordinance, RULE, or regulation for the protection of the
- 4 health and safety of the residents of Baltimore City.

5 **104.6.3 Warrant after prior notice.** Before the Building Official may apply for a warrant to
6 make a routine inspection or spot check to determine if a violation exists, the Building Official
7 must give prior notice of his or her intent to the occupant or other person with apparent right of
8 possession or, in the case of an unoccupied structure or premises, to the owner, the owner's
9 agent, or other person in apparent control of the structure or premises.

10 **104.6.3.1 Contents of notice.** The notice must:

- 11 1. state the date and time at which the Building Official will be present to make the
- 12 inspection or spot check, and
- 13 2. inform the person notified that he or she may reschedule the inspection or spot check
- 14 to a reasonable date and time by contacting the Building Official before the stated
- 15 date.

16 **104.6.3.2 Service of notice – Occupied property.** If the structure or premises is occupied,
17 the notice must be either:

- 18 1. mailed or delivered to the occupant or person with apparent right of possession, or
- 19 2. posted conspicuously at or near the entrance to the structure or premises.

20 **104.6.3.3 Service of notice – Unoccupied property.** If the structure or premises is
21 unoccupied, the notice must be mailed or delivered to the last-known address of the owner,
22 agent, or other person in apparent control.

23 **104.6.3.4 Obtaining warrant.** After notice has been given, if the person notified fails to

4. move a lot line that affects any structure, or
5. perform any grading or excavating.

1. for a demolition or moving permit, by the owner of the property to be demolished or moved,

3. for a permit to do work involving underpinning or a retaining foundation wall, by the licensed contractor employed to do the proposed work, and

- 17 5. specify the number of dwelling units, if any, involved in the proposed work,
- 18 6. be accompanied by the construction documents and other information required by § 107
19 {"SUBMITTAL DOCUMENTS"} of this Code,
- 20 7. if the property is in an Historical and Architectural Preservation District or on the Historical
21 and Architectural Preservation Landmark List or Special List, be accompanied by a Notice to
22 Proceed or a Certificate of Appropriateness from the Commission for Historical and
23 Architectural Preservation,
- 24 8. state the valuation of the proposed work,
- 25 9. if the proposed work will replace any existing structure, be accompanied by photographs that
26 depict the existing conditions and existing structures on the site,

14 3. any other matters the Building Official requires.

15 **105.9.1.2 Written notice to adjoining owners, etc.** The applicant must have given written

18 demolition or moving, and
19 2. the owners of any wired or other facilities that might have to be temporarily removed
20 because of the proposed work.

12 other fees prescribed by law for water taps, sewer connections, electrical permits, signs and display
13 structures, marquees, or other appurtenant structures, or fees for inspections, occupancy permits, or
14 other privileges or requirements, whether within or without the jurisdiction of the Department.

15 **109.3 Minimum fees and service charges.** Fees or service charges for the various permits,
16 certificates, inspections, tests, or other services provided under this Code are as specified in this
17 § 109. Unless otherwise specified, the minimum fee or service charge is \$25. All fees are to be
18 rounded to the nearest dollar.

19 **109.4 Refunds; credits.**

109.5.2 Partial permits. For a partial permit issued under this Code:

IF THE NET PROCEEDS FROM ANY OF THESE ACTIVITIES, OTHER THAN AMUSEMENT DEVICES, ARE TO BE USED EXCLUSIVELY FOR THE BENEFIT OF THE SAME CHARITABLE OR RELIGIOUS ORGANIZATION, THEN ON REQUEST OF THE ORGANIZATION AND SUBMISSION WITH THE PERMIT APPLICATION OF A LIST OF ALL LIKE PERMITS PREVIOUSLY ISSUED FOR THE ORGANIZATION DURING THE SAME CALENDAR YEAR, (I) THE FEE FOR THE 2ND ACTIVITY HELD IN THE SAME CALENDAR YEAR IS WAIVED; AND (II) THE FEE FOR THE 3RD AND EVERY SUBSEQUENT ACTIVITY HELD IN THE SAME CALENDAR YEAR IS REDUCED 50%.

5 **109.6.6 Fees for miscellaneous work.** Permit fees for miscellaneous work, operations, and
6 other purposes, not elsewhere provided for in this Code, are charged at the rate of \$10 for each
7 \$1,000 or fraction of \$1,000 of estimated cost.

8 **109.7 Building Code Permit Tax.** A tax is levied and imposed on every issuance of a permit under
9 this Code. The amount of the tax is 5% of the final cost of that permit rounded up to the nearest
10 whole dollar. The funds so collected are to be deposited to the General Fund and accounted for in a
11 revenue account entitled “Homeless Relief Assistance”, with the legislative intent that an equivalent
12 amount be appropriated in the future for the relief of the homeless.

13 **Section 110 Inspections** *{As in IBC}*

14 **Section 111 Occupancy Permit; Certificate of Completion**

15 **111.1 to 111.4** *{As in IBC. But Note: The “certificate of occupancy” to which the IBC refers is*
16 *known in Baltimore City as an “occupancy permit”}.*

17 **111.5 Certificate of completion.** Within 10 days of written application, the Building Official will
18 issue a certificate of completion if all work authorized by a building permit has been satisfactorily
19 completed in compliance with this Code. The certificate certifies the satisfactory completion of the
20 work and the purpose for which the structure may be used in its several parts.

21 **[111.6 Revocation.** *{As in IBC § 110.5}*]

22 **Section 112 Service Utilities** *{As in IBC}*

23 **Section 113 Board of Appeals** *{Not Adopted}*

24 **Section 114 Violations**

25 **114.1 Unlawful acts.** It is unlawful for any person to:

- 26 1. construct, alter, add to, repair, rehabilitate, demolish, move, locate, use, occupy, or maintain
27 any structure, premises, land, or equipment regulated by this Code, contrary to or in conflict
28 with or in violation of:
 - 29 a. any provision of this Code, or
 - 30 b. any provision of any regulation, order, requirement, decision, permit, or notice
31 issued under this Code by the Building Official or by any other person, board,
32 department, bureau, commission, or agency with jurisdiction, or
- 33 2. otherwise fail to comply with any provision of this Code or of any regulation, order,
34 requirement, decision, permit, or notice issued under this Code, or
- 35 3. cause any of these acts or omissions to be done.

1 **114.2 Violation notice or order.** Except as otherwise provided in this Code, the Building Official
2 may serve a violation notice or order on any person legally responsible for the construction,
3 alteration, addition, repair, rehabilitation, demolition, moving, location, use, occupancy, or
4 maintenance of any structure, premises, land, or equipment in violation of any provision of:

- 5 1. this Code, or
- 6 2. a plan approved under this Code, or
- 7 3. a permit or certificate issued under this Code.

8 **114.2.1 Tenor of notice or order.** The notice or order may direct:

- 9 1. the discontinuance of the illegal action or condition, and
- 10 2. the abatement of the violation, which may include restoration to the prior condition.

11 **114.3 Enforcement generally.** If a violation is not promptly discontinued or abated, or if the
12 violation notice or order is not complied with promptly, the Building Official may institute or cause
13 to be instituted any appropriate legal proceedings.

14 **114.3.1 Types of proceedings.** Enforcement proceedings may include:

- 15 1. injunctive or other equity proceedings, including:
 - 16 A. an action initiated by a code-enforcement-injunction citation under City Code
 - 17 Article 19, § 71-3 {"CODE ENFORCEMENT INJUNCTION"}, or
 - 18 B. an action for appointment of a receiver under § 121 {"VACANT BUILDING
 - 19 RECEIVER"} of this Code,
- 20 2. criminal prosecution, including a prosecution initiated by a prepayable criminal citation
- 21 under City Code Article 19, § 71-2 {"PREPAYABLE CRIMINAL CITATIONS"}, and
- 22 3. administrative proceedings, including one initiated by an environmental citation under
- 23 City Code Article 1, § 40-14 {"VIOLATIONS TO WHICH SUBTITLE APPLIES"}.

24 **114.3.2 Remedies not exclusive.** In pursuing a violation, the Building Official may use any 1 or
25 more available remedies or enforcement actions. The initiation of any 1 remedy or enforcement
26 action does not preclude pursuing any other remedy or enforcement action authorized by law.
27 Neither damages, irreparable injury, nor the lack of an adequate remedy at law is a prerequisite to
28 enforcement in equity.

29 **114.3.3 When prior notice not required.** A violation notice or order is not a prerequisite to
30 enforcement action in the following situations:

- 31 1. when seeking a temporary restraining order or injunction in an emergency,
- 32 2. when seeking equitable relief for a pattern or practice of noncompliance,
- 33 3. for work being done without a permit or in violation of a stop-work order,
- 34 4. for a violation that remains unabated after a prior prosecution for that violation,

- 1 5. for a prepayable criminal citation that is issued under City Code Article 19, Subtitle 71
2 {"Special Enforcement Officers"} and for which prior notice is waived under Article 19,
3 § 71-2 {"PREPAYABLE CRIMINAL CITATIONS"},
- 4 6. for an environmental citation that is issued under City Code Article 1, Subtitle 40
5 {"Environmental Control Board"}, and
- 6 7. in any other case specifically authorized by this Code.

7 **114.4 Violation a misdemeanor.** A person is guilty of a misdemeanor and, on conviction, subject
8 to the penalties specified in this § 114.4, if the person:

- 9 1. violates a provision of this Code,
- 10 2. fails to comply with any requirement of this Code or of a regulation, order, decision, permit,
11 or notice issued under this Code, or
- 12 3. constructs, alters, adds to, repairs, rehabilitates, demolishes, moves, locates, use, occupies,
13 or maintains any structure, premises, land, or equipment in violation of an approved plan or
14 directive of the Building Official or of a permit or certificate issued under this Code.

15 **114.4.1 Notice required.** Except as otherwise specifically authorized by law, criminal
16 proceedings may not be initiated unless the Building Official issues a notice of violation and
17 allows a period within which to abate the violation.

18 **114.4.2 Each day a separate offense.** Each day that a violation continues is a separate offense.
19 Proof that a violation exists on any date after issuance of a violation notice is prima facie
20 evidence that the violation has continued unabated throughout the intervening period.

21 **114.4.3 Penalties.** The penalty for each offense is as follows:

- 22 1. for work done without a permit or in violation of a stop-work order, a fine of not more
23 than \$500 or imprisonment for not more than 90 days or both fine and imprisonment, and
- 24 2. for all other violations, a fine of not more than \$500.

25 **114.5 Civil penalties and costs.** In equity proceedings instituted under this Code:

- 26 1. a violation for which equitable relief is sought is subject to a civil fine of not more than \$500
27 for each day that the violation continues unabated,
- 28 2. the defendant is liable for the plaintiff's enforcement costs and reasonable attorneys' fees, at
29 the rate established by the Court of Appeals, whether or not the attorney is a salaried
30 employee of the plaintiff, and
- 31 3. judgment may be sought for outstanding liens imposed by the City on property subject to the
32 proceeding and owned by the defendant.

33 **114.6 Additional legal action.** The imposition of penalties does not preclude the City Solicitor
34 from instituting appropriate legal proceedings to:

- 35 1. prevent unlawful construction,
- 36 2. restrain, correct, or abate a violation,

- 1 3. prevent illegal occupancy of a structure or premises, or
- 2 4. stop an illegal act, conduct, business, or use of a structure on or about any premises.

3 **114.7 to 114.10 {Reserved}**

4 **114.11 Revoking or withholding violator's permits.**

5 **114.11.1 Scope.** This § 114.11 applies whenever the Building Official finds that an owner, AN
6 OWNER'S AGENT, A contractor, or AN architect, engineer, or other design professional has
7 violated a provision of this Code, of a permit, or of the rules and regulations of any department or
8 agency of the City in connection with the construction, alteration, addition, repair, rehabilitation,
9 demolition, moving, location, use, occupancy, or maintenance of any structure, premises, land, or
10 equipment.

11 **114.11.2 Actions authorized.** In any situation described in § 114.11.1, the Building Official
12 may:

- 13 1. revoke, without prior notice, any existing permit that has been granted:
 - 14 a. to the owner, THE OWNER'S AGENT, THE contractor, OR THE architect, engineer, or
15 other design professional, or
 - 16 b. for work in connection with which the design professional is employed, and
- 17 2. refuse to grant, for a period of up to 5 years, any further permits:
 - 18 a. to the owner, THE OWNER'S AGENT, THE contractor, OR THE architect, engineer, or
19 other design professional, [or]
 - 20 b. for work in connection with which the design professional is employed,
 - 21 c. FOR WORK ON THE PROPERTY WITH RESPECT TO WHICH THE VIOLATION
22 OCCURRED,

23 **114.12 to 114.13 {Reserved}**

24 **114.14 Work without permit.** Any person who does work without a permit, outside or beyond the
25 scope of a permit, or in a manner inconsistent with plans or drawings approved as part of a permit
26 application:

- 27 1. is in violation of this Code and subject to enforcement action without notice,
- 28 2. must immediately stop any work in progress,
- 29 3. must obtain a permit, paying all associated fees and penalties, whether the work is in
30 progress or completed, and
- 31 4. must restore the structure to its original condition, unless:
 - 32 a. the work otherwise conforms to the relevant requirements of law, and
 - 33 b. the Building Official, in his or her discretion, allows the work to remain or continue.

34 **114.15 to 114.20 {Reserved}**

1 **114.21 Responsibility of owners and operators.** Except as otherwise specifically provided in
2 § 114.21.1, the owner and the operator of any property subject to this Code are each:

- 3 1. responsible for compliance with all provisions of this Code in all matters pertaining directly
4 or indirectly to that property, and
- 5 2. liable for all violations of this Code in connection with any land, structure, matter, or thing
6 owned or controlled by them.

7 **114.21.1 Exceptions.** Only the owner is responsible for compliance with a provision requiring
8 an owner's signature. Except as specified in § 114.21.2, an owner or operator is not responsible
9 for compliance with a provision of this Code that is specifically designated as the responsibility
10 of the occupant, unless that owner or operator is also an occupant.

11 **114.21.2 Liability for sanitary maintenance.**

12 **a. Secondary liability.** If, after a notice, order, or citation, a tenant fails to correct a
13 violation of Property Maintenance Code § 305 {"Exterior sanitary maintenance –
14 General"} or § 306 {"Exterior sanitary maintenance – Trash, garbage, and debris"} for
15 which occupants are responsible under Property Maintenance Code § 308 {"Occupant's
16 sanitary responsibilities"}, the owner and operator of the property are secondarily liable.

17 **b. Liability – Failure to register property.** The owner of a property is responsible for
18 exterior sanitary maintenance if:

- 19 1. the owner fails to register or license the property as required by City Code
20 Article 13, Subtitle 4 {"Non-Owner-Occupied Dwellings, ETC."} or Subtitle 5
21 {"Multiple-Family Dwellings"}, or
- 22 2. reasonable attempts at telephone contact, using information in a current
23 registration statement, do not lead within 2 business days to current occupant
24 information.

25 **c. Liability – Third environmental citation.** The owner of a property is responsible for
26 exterior sanitary maintenance if:

- 27 1. within the previous 12 months, two or more environmental citations were issued
28 under City Code Article 1, Subtitle 40 {"ENVIRONMENTAL CONTROL BOARD"},
29 for violations of this Code that were the responsibility of an occupant of the
30 property under Property Maintenance Code [§ 307] § 308 {"Occupants' Sanitary
31 Responsibilities"}, and
- 32 2. notification of each citation has been sent to the owner by regular mail.

33 **114.21.2.1 Notice to owner, operator.** Before an owner or operator may be charged
34 under § 114.21.2a {"Secondary liability"}, he or she must be served with a violation notice
35 under § 123.4 {"VIOLATION NOTICES"}. A violation notice under § 123.4 is not necessary to
36 charge an owner under §§ 114.21.2b {"Liability – Failure to Register Property"} or
37 114.21.2c {"Liability – Third environmental citation"}.

38 **114.21.2.2 Recovery of expenses.** If an owner or operator incurs expenses in correcting the
39 violation, the owner or operator:

- 1 1. may bring legal action to recover those expenses from the tenant, and
- 2 2. has all the rights and remedies available under the law for nonpayment.

3 **114.22 Responsibility of others.** In addition to the owner or operator of the property involved, any
4 other person who violates any provision of this Code is liable for the violation and, on conviction, is
5 subject to all penalties provided in this Code for the violation.

6 **114.23 Responsibility of transferee.** This § 114.23 applies whenever any property is transferred by
7 sale, assignment, ground rent lease, or otherwise, with or without consideration (“transfer”). Except
8 as provided in § 114.25 {“RESPONSIBILITY OF MORTGAGEES”}, this § 114.23 does not apply to a
9 mortgagee or to the holder of a note secured by a deed of trust.

10 **114.23.1 Duty before transfer.** Before any transfer of property, the transferee must obtain a
11 copy of a violation report for the property.

12 **114.23.2 Primary liability of transferee.** On transfer of the property, if any violation or
13 condemnation notices lie against the property and are included in the violation report, the
14 transferee:

- 15 1. becomes primarily liable for those notices the same as if the notices had been addressed
16 to the transferee,
- 17 2. must abate the violation, and
- 18 3. is liable in accordance with § 117 {“EMERGENCY AND CORRECTIVE MEASURES”} of
19 this Code for any expenses incurred by the City in abating the violation or condemnation
20 notice, if the transferee failed to request a violation report as required by § 114.23.1.

21 **114.23.3 Reliance on violation report.** A transferee is not liable for abatement expenses
22 incurred by the City if, before the transfer, the transferee requested a violation report and the
23 report does not show the violation.

24 **114.24 Responsibility of officers, directors, etc., of corporations, partnerships, etc.** Whenever a
25 corporation, joint stock company, partnership, association, limited liability company, or other entity
26 violates any provision of this Code, every officer, director, trustee, partner, member, or agent of that
27 entity who has authorized or done any of the acts constituting the violation, in whole or in part, or
28 who has failed to act or acquiesced in any failure to act constituting the violation, in whole or in part,
29 is individually guilty of a misdemeanor and, on conviction, is subject to the penalties provided in this
30 § 114.

31 **114.25 Responsibility of mortgagee.** A person that acquires an interest in property by way of a
32 mortgage or deed of trust (“lender”) is liable to the same extent as an owner/transferee for a violation
33 or condemnation notice pertaining to a vacant unsafe structure, if:

- 34 1. the person with primary responsibility fails to comply with the notice,
- 35 2. the lender has been notified by certified mail of the violation or condemnation notice, and
- 36 3. within 180 days after the receipt of the notice:
 - 37 a. ratification of a foreclosure sale of the property has not occurred, or
 - 38 b. the lender has not released its mortgage or deed of trust.

1 **114.25.1 Bankruptcy toll.** The 180-day period referred to in § 114.25(3) is tolled by any period
2 during which the lender's right to foreclose is stayed by a pending proceeding under the federal
3 Bankruptcy Code.

4 **114.25.2 Defense.** During any enforcement proceeding instituted against a lender under this
5 section, it is a defense that the lender did not have the right to institute foreclosure proceedings.

6 **114.25.3 During pendency of foreclosure.** During the pendency of a foreclosure, the lender is
7 responsible for maintaining the property free from high vegetation, and FREE from accumulation
8 of trash and debris, AND OTHERWISE IN FULL COMPLIANCE WITH THE REQUIREMENTS OF THIS
9 CODE.

10 **114.26 Responsibility of buyer on foreclosure.** On foreclosure or sale in lieu of foreclosure, the
11 buyer:

- 12 1. acquires ownership responsibility when the sale is ratified, and
- 13 2. takes title subject to any outstanding notices.

14 Section 115 Stop-Work Order

15 **115.1 Authority.** *{As in IBC}*

16 **115.2 Issuance.** The stop-work order must be in writing and state the reason for the order. It must
17 be posted on the property. On posting, the cited work must immediately cease. Written notice of the
18 stop-work order must be sent by first class and certified mail to the owner of the property involved.

19 **115.3 Unlawful continuance.** *{As in IBC}*

20 **115.4 Removal, etc., of posted notice.** Until the Building Official so authorizes, no person may
21 remove, deface, damage, or change any notice, poster, or sign placed under this section on any land,
22 structure, or other object.

23 Section 116 Unsafe Structures

24 **116.1 General.** Any structure or part of a structure found to be unsafe or unfit for human habitation
25 or other authorized use must be rehabilitated or, as permitted or required by the Building Official,
26 demolished.

27 **116.1.1 Scope.** A structure may be unsafe or unfit for human habitation or other authorized
28 use because of:

- 29 1. conditions constituting a fire hazard or conditions of damage, decay, dilapidation,
30 obsolescence, abandonment, vacancy (as described in § 116.4), insanitation, or vermin
31 or rodent infestation that constitute a hazard to the health, welfare, or safety of occupants
32 or the public,
- 33 2. lack of sanitation, illumination, ventilation, heating, plumbing, exitways, fire protection,
34 utilities, or other facilities adequate to protect the health, welfare, or safety of occupants
35 or the public, or
- 36 3. conditions that are so unsafe, insanitary, overcrowded, improper in use or occupancy, or
37 otherwise dangerous to life, health, welfare, or safety as to create a hazard to occupants
38 or the public.

1 **116.2 Occupied unsafe structures.** Whenever the Building Official or the Commissioner of Health
2 finds all or any part of an occupied structure to be unsafe or unfit for human habitation or other
3 authorized use:

- 4 1. either the Building Official or Commissioner of Health may:
 - 5 a. post an order requiring the structure or affected part to be vacated, and
 - 6 b. take necessary steps to remove occupants who fail or refuse to vacate,
- 7 2. once vacated, the structure or affected part may not be reoccupied until:
 - 8 a. it is rehabilitated to comply with all applicable codes and ordinances, and
 - 9 b. the Building Official has issued an occupancy permit, and
- 10 3. pending rehabilitation, the structure must be kept secure against casual entry and the
11 premises kept free of occupants, litter, high grass, and weeds.

12 **116.3 Temporarily unoccupied structures.** Any structure or part of a structure that has been left
13 unoccupied without removing appliances or portable equipment or furniture and without
14 disconnecting utility service must be safeguarded by closing and securely locking all windows,
15 doors, and other openings.

16 **116.4 Unsafe vacant structures.** Every vacant structure, as defined in this § 116.4, is declared to
17 be a fire hazard and a nuisance per se, and must be safeguarded and otherwise maintained as required
18 in this § 116.4.

19 **116.4.1 Definition.** “Vacant structure” means an unoccupied structure that is unsafe or unfit for
20 human habitation or other authorized use.

21 **116.4.2 Determinations.** A determination of vacancy and a determination of noncompliance
22 with a notice or order issued under this section may be based on observation that a structure:

- 23 1. is open to casual entry,
- 24 2. has boarded windows or doors, or
- 25 3. lacks intact window sashes, walls, or roof surfaces to repel weather entry.

26 **116.4.3 Required safeguarding.** Every vacant structure must be cleaned, closed, and
27 safeguarded as follows:

- 28 1. Before the structure is closed and secured, all litter, trash, and other debris must be
29 removed from the premises.
- 30 2. All windows, doors, and other openings must be closed, securely locked, and, if within
31 24 feet of the ground or readily accessible, further protected by boarding up with
32 substantial material, including masonry, approved by the Building Official. The Building
33 Official may require windows facing streets to be boarded with lexan, vinyl, or similar
34 material, protected by security grills, or both.
- 35 3. As long as the structure remains unrehabilitated:
 - 36 a. it must be kept boarded,

- 1 b. the premises must be conspicuously posted against trespass, and
- 2 c. the premises must be kept free of occupants, litter, trash, debris, high grass, and
- 3 weeds at all times.
- 4 4. Boarding, posting, and cleaning, however, do not relieve the owner of responsibility to
- 5 demolish or to repair and maintain the property in conformity with this Code.
- 6 5. The structure may not be reoccupied until the Building Official has issued an occupancy
- 7 permit.

8 **116.4.4 Emergency condition.** A vacant structure that is not kept boarded and free from
9 accumulations of debris and high vegetation or that, in the opinion of the Building Official, is so
10 dangerously unsound or so deteriorated that rehabilitation is not feasible, constitutes an
11 emergency condition that imminently threatens the public health and safety and requires
12 immediate resolution.

13 **116.4.5 Rodenticide procedure.** *See* [§ 3313] § 3314 of this Code.

14 **116.4.6 Notice to Public Works.** Whenever the Building Official determines a structure to be
15 vacant, the Building Official must promptly notify the Director of Public Works of that
16 determination. On receipt of the notice, the Director of Public Works must proceed to cut off
17 water service, as provided in City Code Article 24, § 2-3 {"CUT-OFF FOR NONPAYMENT"}.

18 **116.5 Rehabilitation, demolition, and stabilization.** Except as otherwise authorized or required
19 under this section, a structure found to be unsafe or unfit for human habitation or other authorized
20 use must be rehabilitated AND AN OCCUPANCY PERMIT OBTAINED.

21 **116.5.1 Permitted demolition.** On timely appeal of an order to rehabilitate, the Building
22 Official may permit an owner to demolish an unsafe structure instead of rehabilitating it if, in the
23 Building Official's opinion, demolition is not detrimental to the immediate neighborhood.

24 **116.5.2 Required demolition.** The Building Official may order the immediate demolition of
25 any unsafe structure that, in the Building Official's opinion, is either so dangerously unsound or
26 so deteriorated that rehabilitation is not feasible.

27 **116.5.2.1 Appeal.** The recipient of an order to demolish an unsafe structure may request
28 administrative review of the order under § 128 {"ADMINISTRATIVE AND JUDICIAL REVIEW"}
29 of this Code.

30 **116.5.2.2 Rescission of demolition order.** The Building Official may rescind or modify
31 a demolition order if the owner demonstrates the financial ability and requisite expertise to
32 rehabilitate the structure within a reasonable time, as determined by the Building Official,
33 and agrees to comply with a specified timetable. Failure to comply with an agreed timetable
34 reinstates the demolition order.

35 **116.5.3 Stabilization.** The Building Official may permit or order an interim stabilization of an
36 unsafe structure pending its rehabilitation.

37 **116.5.4 Reoccupancy of rehabilitated structure.** A structure declared unsafe or unfit for
38 occupancy may not be reoccupied until the Building Official has:

- 39 1. abated the violation notice or order, and
- 40 2. issued an occupancy permit.

1 **116.6 Vacant lot maintenance.** When a structure has been demolished under this § 116, the
2 premises must be made to conform to the provisions of this Code and of the regulations adopted
3 under this Code.

4 **116.7 Remedial action by Building Official.** The Building Official may take action under this
5 § 116.7 whenever the owner, agent, or person in control cannot be found or fails to comply with a
6 notice or order served under this Code:

- 7 1. to repair, rehabilitate, stabilize, or demolish an unsafe structure,
- 8 2. to clean, close, board, or otherwise safeguard a vacant structure, or
- 9 3. to remove high grass and weeds or litter, trash, and debris from the premises of a
10 vacant structure.

11 **116.7.1 Actions authorized.** The Building Official may proceed to:

- 12 1. have a receiver appointed, or
- 13 2. complete all or any part of the required work through officers, agents, employees,
14 or contractors.

15 **116.7.2 Entry to property.** Before taking any remedial action, the Building Official may enter
16 the premises, without additional notice, to determine the extent of deterioration and the
17 feasibility of rehabilitation.

18 **116.7.3 When additional notice not required.** Boarding, cleaning, and otherwise safeguarding
19 a vacant structure that is subject to an expired violation notice is an emergency action that
20 requires no additional prior notice.

21 **116.7.4 Remedies nonexclusive.** Remedial action under this § 116 does not preclude any other
22 enforcement action authorized by this Code.

23 **116.8 {Reserved}**

24 **116.9 “Abandoned” property.** If a property is cited as “vacant” or “unfit for human habitation” on
25 a violation notice issued under this § 116, the property is considered to be cited as “abandoned” or to
26 be in need of substantial repair within the meaning of the State Tax-Property Article, Title 14,
27 Subtitle 8.

28 **116.10 Effect of designation.** On issuance of a violation notice that designates a structure to be a
29 vacant structure, the structure is deemed to be condemned.

30 Section 117 Emergency and Corrective Measures

31 **117.1 Power of Building Official in emergencies.** In an emergency where life, health, safety, or
32 property is in immediate danger, the Building Official may immediately take any action necessary to
33 protect the endangered life, health, safety, or property, without complying with the notice provisions
34 of this Code.

35 **117.2 Photographs of dangerous conditions.** In all emergencies, if it is practical and if enough
36 time is available to do so, the Building Official must cause the dangerous or unsafe condition that
37 created the emergency to be photographed before any demolition or other work or operation is begun
38 to eliminate the dangerous or unsafe condition.

1 **117.3 Closing streets.** When necessary for the public safety, the Building Official may temporarily
2 close adjacent structures and request the Director of General Services to close adjacent sidewalks,
3 streets, and other public ways and prohibit them from being used. The Building Official may
4 temporarily close adjacent sidewalks, streets, and other public ways only pursuant to an agreement
5 with the Department of General Services.

6 **117.4 Labor and material for emergency work.** In an emergency where life, health, safety, or
7 property is in immediate danger and it is necessary to perform any work or operation to protect that
8 life, health, safety, or property, the Building Official may employ the persons and buy the materials
9 needed to perform the work or operation as expeditiously as possible.

10 **117.5 Liability for costs of emergency work.** Liability for expenses incurred in the course of
11 performing emergency work and the procedure for collecting resultant debts and liens are as provided
12 in § 118 {"LIABILITY FOR EXPENSES..."} of this Code.

13 Section 118 Liability for Expenses And Collection of Debts and Liens

14 **118.1 Scope.** This § 118 applies to all cases where:

- 15 1. the Building Official enforces any provision of this Code, including but not limited to:
 - 16 a. the elimination of any safety, health, or fire hazard,
 - 17 b. the elimination of any nuisance, blight, or insanitary condition,
 - 18 c. the removal of any abandoned or illegally constructed structure or other object, or
 - 19 d. the taking of any corrective action in emergencies or otherwise, and
- 20 2. in connection with those efforts, the Building Official:
 - 21 a. furnishes or causes to be furnished any labor, supervision, equipment, or materials,
22 or
 - 23 b. performs or causes to be performed any inspection, work, or operation to eliminate
24 the hazard or condition or to remove the structure or other object.

25 **118.2 Liability and lien for expenses.** In the cases described in § 118.1, the entire amount of the
26 Building Official's expenditures, together with all incidental costs and all accrued penalties:

- 27 1. are a personal debt owed to the City jointly and severally by every person made liable under
28 this Code, and
- 29 2. are a lien in favor of the City on the land and improvements in respect to which the
30 expenditures were made.

31 **118.3 When debts and liens become effective.** All debts become due and owing to the City
32 immediately when the work is completed or the expenditure made. All liens become effective
33 immediately after the Building Official notifies the Bureau of Liens that appropriate notice has been
34 given or that a structure has been posted in accordance with this Code.

35 **118.4 Collection of debts and liens.** All debts due and liens incurred under this § 118:

- 36 1. are collectible from any assets of the persons made liable under this Code, including a former
37 owner, and

- 1 2. may be collected and enforced in the same way that the City collects and enforces other debts
2 due to it or liens in its favor.

3 **118.5 Priority over other liens and encumbrances.** All debts and liens incurred under this § 118
4 have priority over all other liens and encumbrances, except taxes or other government assessments.

5 **Section 119 {Reserved}**

6 **Section 120 Condemnation Proceedings**

7 **120.1 In general.** If any land, structure, or equipment becomes unsafe or dangerous to public health
8 or safety, the Building Official may condemn the land, structure, or equipment as provided in this
9 § 120 and issue a condemnation notice as provided in § 123 {"NOTICES"} of this Code. The issuance
10 of a violation notice is not a prerequisite for the condemnation of real property.

11 **120.2 Posting notice.** If the Building Official condemns any land, structure, or equipment, the
12 Building Official must cause a notice to be conspicuously displayed on the condemned land,
13 structure, or equipment.

14 **120.2.1 Contents.** The notice must:

- 15 1. be at least 24 INCHES WIDE [by 36] 18 inches HIGH,
16 2. be signed by the Building Official, and
17 3. advise the public that:
18 a. the particular land, structure, or equipment has been condemned as being
19 unsafe or dangerous for occupancy or use, and
20 b. the public is warned to keep away.

21 **120.2.2 Emergencies.** In case of an emergency where life or property may be in immediate
22 danger, the Building Official need not post the property and may proceed in accordance with
23 § 117 {"EMERGENCY AND CORRECTIVE MEASURES"} of this Code.

24 **120.3 Vacating condemned property.** A notice posted under § 120.2 is deemed to be sufficient
25 warning to all occupants of the condemned property to leave immediately. If any occupant fails to
26 vacate the property immediately after the notice is posted, the Building Official may take whatever
27 action is proper and expedient to remove that occupant.

28 **120.4 Receiver of condemned property.** After a property is condemned, the Building Official
29 may:

- 30 1. take any action authorized under § 120.7, or
31 2. in accordance with § 121 {"VACANT BUILDING RECEIVER"} of this Code, apply to court for
32 the appointment of a receiver.

33 **120.5 Status of condemned property.** After property has been condemned and posted in
34 accordance with this § 120, that property remains condemned and may not be occupied or used again
35 until the Building Official declares the property safe for occupancy or use and has removed the
36 condemnation.

1 **120.6 Order to demolish.** If, in the Building Official's opinion, a structure is so dangerously
2 unsound or so deteriorated that rehabilitation is not feasible, the condemnation notice may order the
3 owner to demolish the structure immediately.

4 **120.7 Removal of unsafe conditions.** Anytime after property has been posted in accordance with
5 this § 120, the Building Official may demolish, move, alter, repair, rehabilitate, rebuild, reconstruct,
6 or take any other appropriate action to eliminate or make safe and secure any dangerous or unsafe
7 condition. Before doing so, however, the Building Official must provide the notice required by
8 § 105.9 {"SPECIAL REQUIREMENTS FOR DEMOLITION OR MOVING"} of this Code.

9 **120.8 Condemnation of electrical work.** If any electrical wiring or equipment that has been the
10 subject of a condemnation notice is not made safe within the time required by the condemnation
11 notice, the wiring or equipment must be put out of service by cutting off all electric current to it and
12 by sealing all switches that operate in connection with the wiring or equipment.

13 **120.8.1 Emergency action.** In case of an emergency where life or property is in immediate
14 danger, the Building Official may order all electric current serving the wiring or equipment to be
15 cut off and all switches that control the wiring or equipment to be sealed. The Building
16 Official's orders must be complied with immediately, regardless of any other provisions of this
17 Code that might apply.

18 **120.8.2 Permission needed to reactivate.** Whenever electric current has been cut off or
19 switches have been sealed under this § 120.8, the electric current may not be cut in and the seals
20 may not be broken, except by an authorized agent of the Building Official, after all requirements
21 of the Building Official have been complied with and the Building Official has issued a
22 certificate of approval.

23 **120.9 Condemnation of mechanical work.** If any mechanical equipment that has been the subject
24 of a condemnation notice is not made safe within the time required by the condemnation notice, the
25 mechanical equipment must be put out of service and sealed.

26 **120.9.1 Emergency action.** In case of an emergency where life or property is in immediate
27 danger, the Building Official may order the mechanical equipment to be put out of service and
28 sealed. The orders of the Building Official must be complied with immediately, regardless of
29 any other provisions of this Code that might apply.

30 **120.9.2 Permission needed to reactivate.** Whenever mechanical equipment has been put out of
31 service and sealed under this § 120.9, the mechanical equipment may not be put back in service
32 and the seals may not be broken, except by an authorized agent of the Building Official, after all
33 requirements of the Building Official have been complied with and the Building Official has
34 issued a certificate of approval.

35 Section 121 Vacant Building Receiver

36 **121.1 Scope.** This § 121 applies to a vacant structure, as defined in § 116.4 {"UNSAFE VACANT
37 STRUCTURES"}, for which a notice or order to rehabilitate or to demolish is outstanding.

38 **121.2 In general.** The Building Official may petition the court for appointment of a receiver to
39 rehabilitate a vacant property, to demolish it, or to sell it to a qualified buyer.

40 **121.3 Contents of petition.** The petition for appointment of a receiver must include:

- 41 1. a copy of the original violation notice or order, and
- 42 2. a verified pleading that:

- 1 a. avers that the required rehabilitation or demolition has not been completed, and
- 2 b. identifies and states the qualifications of the proposed receiver, if other than the
- 3 Building Official.

4 **121.4 Named respondents.** The petition for appointment of receiver must name as respondents:

- 5 1. the owner of the property,
- 6 2. any mortgagee, and
- 7 3. the plaintiff in any proceeding that was timely filed under State Tax-Property Article
- 8 § 14-833 {“[Complaints to foreclose] FORECLOSING right of redemption”} and for which the
- 9 time for securing a decree of foreclosure has not yet expired.

10 **121.4.1 Effect of failure to name plaintiff.** Failure to name a person described in § 121.4(3)

11 does not prevent the action from going forward, but does prevent the receiver’s lien for expenses

12 incurred in rehabilitating, demolishing, or selling the vacant building from having priority over

13 that person’s lien interest.

14 **121.5 Filing with Bureau of Liens.** A notice of the proceeding, together with a copy of the

15 violation notice or order, must be filed with the Bureau of Liens. The Bureau must include a record

16 of these in its lien reports, and the property cannot be transferred without the prior approval of the

17 court.

18 **121.6 Notice to judgment creditors and lien holders.** [Within 10 days after] AFTER filing the

19 petition AND BEFORE A RECEIVER IS APPOINTED, the Building Official must give notice of the

20 pendency and nature of the proceedings by regular and certified mail to the last-known addresses of

21 all judgment creditors and lien holders with a recorded interest in the property. HOWEVER, THIS

22 NOTICE IS NOT REQUIRED FOR RESPONDENTS NAMED UNDER § 121.4 {“NAMED RESPONDENTS”} OF

23 THIS CODE.

24 **121.6.1 Intervention.** Within 30 days of the date on which the notice was mailed, a judgment

25 creditor or lien holder may apply to intervene in the proceeding and to be appointed under

26 § 121.7.

27 **121.6.2 Effect of failure to give notice.** Failure to give any required notice to any interested

28 person under this § 121 does not prevent the action from going forward, but does prevent the

29 receiver’s lien for expenses incurred in rehabilitating, demolishing, or selling the vacant building

30 from having priority over that person’s lien interest.

31 **121.7 Appointment of owner, etc., instead of receiver.** Instead of appointing a receiver to

32 rehabilitate or sell a vacant building, the court may permit an owner, mortgagee, or other person with

33 an interest in the property to rehabilitate or demolish it, if that person:

- 34 1. demonstrates ability to complete the rehabilitation or demolition within a reasonable time,
- 35 2. agrees to comply with a specified schedule for rehabilitation or demolition, and
- 36 3. posts bond, in an amount determined by the court, as security for performance of the
- 37 required work in compliance with the specified schedule.

38 **121.7.1 Application to dismiss owner.** If it appears to the petitioner that the person appointed

39 is not proceeding with due diligence or in compliance with the court-ordered schedule, the

Council Bill 12-0123

1 petitioner may apply to the court for immediate revocation of that person's appointment and for
2 appointment of a receiver. The bond posted under this section must then be applied to the
3 subsequently appointed receiver's expenses in rehabilitating, demolishing, or selling the vacant
4 building.

5 **121.8 Appointment of receiver.** If no qualified person with an ownership interest requests
6 appointment to rehabilitate or demolish the property, or if an appointee is dismissed, the court must
7 then appoint a receiver of the property for the purpose of rehabilitating and managing the property,
8 demolishing the property, or selling it to a qualified buyer.

9 **121.8.1 Parties divested of authority.** On appointment of a receiver to rehabilitate, demolish,
10 or sell the property, all parties are divested of any authority to act in furtherance of those goals.

11 **121.8.2 Penalties.** Any party who takes any step to rehabilitate, demolish, or sell the property
12 is subject to the penalties for contempt.

13 **121.9 Powers of receiver appointed to rehabilitate or demolish.** A receiver appointed to
14 rehabilitate or demolish a vacant building, in addition to all necessary and customary powers, has the
15 right of possession with authority to:

- 16 1. contract for necessary labor and supplies for rehabilitation or demolition,
- 17 2. borrow money for rehabilitation or demolition from an approved lending institution or
18 through a government agency or program, using the receiver's lien against the property as
19 security,
- 20 3. manage the property after rehabilitation, with all the powers of a landlord, for a period of up
21 to 2 years and apply the rent received to current operating expenses and to repayment of
22 outstanding rehabilitation expenses, and
- 23 4. foreclose on the receiver's lien or accept a deed in lieu of foreclosure.

24 **121.10 Powers of receiver appointed to sell.** A receiver appointed to sell a vacant building, in
25 addition to all necessary and customary powers, has authority to[: 1.] sell the property to the high
26 bidder at public auction, following the [same presale notice] provisions that apply to a [foreclosure,
27 or] RECEIVER APPOINTED UNDER RULE 3-722 {"RECEIVERS"} AND TITLE 14, CHAPTER 300
28 {"JUDICIAL SALES"} OF THE MARYLAND RULES. [2. sell the property privately for fair market value
29 if no party to the receivership objects to the amount and procedure.]

30 **121.10.1 Notice of auction.** In the notice of public auction, it is sufficient to describe the
31 property by a street address and by reference to the liber and folio number of the title deed
32 recorded in the land records of Baltimore City.

33 **121.10.2 Buyer qualifications.** Before any sale, the applicants to bid in a public sale or the
34 proposed buyer in a private sale must demonstrate the ability and experience needed to
35 rehabilitate the property within a reasonable time.

36 **121.10.3 Application of sale proceeds.** After deducting the expenses of the sale, the amount of
37 outstanding taxes and other government assessments, and the amount of the receiver's lien, the
38 receiver must apply any remaining proceeds of the sale, first to the petitioner's costs and
39 expenses, including reasonable attorney's fees, and then to the liens against the property in order
40 of priority.

1 **121.11 Tenure of receiver appointed to rehabilitate.** The tenure of a receiver appointed to
2 rehabilitate a vacant building may extend no longer than 2 years after rehabilitation. Anytime after
3 rehabilitation, any party to the receivership may file a motion to dismiss the receiver on payment of
4 the receiver's outstanding costs, fees, and expenses.

5 **121.12 Final accounting.** At the end of the receiver's tenure, the receiver must file a final
6 accounting with the court.

7 **121.13 Receiver's lien for costs, etc.** Any costs or fees incurred by the receiver are a lien against
8 the property in accordance with § 118 {"LIABILITY FOR EXPENSES ..."} of this Code. The receiver's
9 lien has priority over all other liens and encumbrances, except taxes or other government
10 assessments. The receiver must allow the petitioner's costs and expenses, including reasonable
11 attorney's fees, to be paid to the extent that the proceeds of the sale permit.

12 **121.13.1 Foreclosure of lien.** A receiver may foreclose on the lien by a sale of the property at
13 public auction, following 1 public notice and notice to interested parties in the manner of a
14 mortgage foreclosure. After deducting the expenses of the sale, the receiver must apply the
15 proceeds of the sale to the liens against the property, in order of priority. In lieu of foreclosure,
16 and only if the receiver has rehabilitated the property, an owner may pay the receiver's costs,
17 fees, including attorney's fees, and expenses or may transfer all ownership in the property to
18 either the receiver or an agreed-on third party for an amount agreed to by all parties to the
19 receivership as being the property's fair market value.

20 **121.14 Transfer on sale.** Following court ratification of a sale, the receiver must sign a deed
21 conveying title to the buyer, free and clear of all encumbrances.

22 **121.15 Dismissal.** On sale of the property, the receiver must:

- 23 1. file with the court a final accounting, and
- 24 2. at the same time, file a motion with the court to dismiss the action.

25 **Section 122 {Reserved}**

26 **Section 123 Notices**

27 **123.1 In general.** All notices under this Code must be issued in accordance with this § 123.
28 However, nothing in this Code may be construed to excuse or relieve any person from complying
29 with all provisions of this Code at all times, regardless of whether any notice or order has been issued
30 by the Building Official in any particular case.

31 **123.2 Classification.** Notices issued under this Code are classified as either:

- 32 1. condemnation notices, or
- 33 2. violation notices.

35 **123.3 Contents – Condemnation notices.** Except as specified in § 123.3.1, every condemnation
36 notice must set forth:

- 37 1. the location of the condemned structure or equipment,
- 38 2. the reason the structure or equipment is condemned,
- 39 3. a reference to applicable provisions of this Code,

- 1 4. a warning against entering or using the condemned structure or equipment,
- 2 5. the right of the person to whom the notice is directed to request a hearing within
- 3 10 days of the date on which the notice was served, and
- 4 6 unless to be contained in a follow-up or subsequent notice:
 - 5 a. a statement of the requirements that must be complied with to rectify the unsafe
 - 6 condition,
 - 7 b. the time within which the unsafe condition must be rectified, and
 - 8 c. the Building Official's authority under § 123.8 {"FAILURE TO COMPLY WITH NOTICE
 - 9 OR CITATION"} to take action at the owner's expense.

10 **123.3.1 Follow-up notices.** A follow-up or other subsequent notice involving the same
11 condemnation need not repeat the information contained in a prior notice as long as the
12 subsequent notice identifies the prior notice.

13 **123.4 Violation notices.** Except as specified in § 123.4.1, every violation notice must set forth:

- 14 1. the location and character of the violation,
- 15 2. a reference to applicable provisions of this Code,
- 16 3. the right of the person to whom the notice is directed to request a hearing within 10 days of
- 17 the date on which the notice was served, and
- 18 4. unless to be contained in a follow-up or subsequent notice:
 - 19 a. a statement of the requirements that must be complied with to rectify the violation,
 - 20 b. the time within which the violation must be rectified, and
 - 21 c. the Building Official's authority under § 123.8 {"FAILURE TO COMPLY WITH NOTICE
 - 22 OR CITATION"} to take action at the owner's expense.

23 **123.4.1 Follow-up notices.** A follow-up or other subsequent notice involving the same
24 violation need not repeat the information contained in a prior notice as long as the subsequent
25 notice identifies the prior notice.

26 **123.5 When notices to be issued.** Except as otherwise specified in this Code, notices must be
27 issued in all cases where legal proceedings might be necessary to enforce this Code.

28 **123.5.1 Condemnation notices.** For any land, structure, or equipment being condemned, the
29 condemnation notice must be issued to the owner of the land, structure, or equipment.

30 **123.5.2 Violation notices.** For violations, the violation notice must be issued to the person who
31 committed or otherwise is responsible for the violation.

32 **123.6 Service of notice – General.** Except as otherwise specified in § 123.7 {"SERVICE OF NOTICE
33 – POSTING"}, all notices issued by the Building Official must be served on the person that the notice
34 is intended for or on any authorized agent or representative of that person.

1 **123.6.1 More than 1 person responsible.** If more than 1 person is responsible for the violation
2 or responsible for complying with this Code, as in a case of property owned by more than 1
3 person, notice may be served on any 1 of those persons or on any authorized agent or
4 representative of any of them.

5 **123.6.2 Method of service.** A notice is properly served if:

- 6 1. served personally on the owner, agent, person in control, former owner, or other person
7 responsible for the property,
- 8 2. hand delivered to that person's home, business, or tax record address, or
- 9 3. sent by certified or registered mail to that person's home, business, or tax record address.

10 **123.6.3 Authorized server.** Service under § 123.6.2(1) or (2) must be made by:

- 11 1. a member of the Baltimore City Police Department, or
- 12 2. an official or employee of the City or the State of Maryland.

13 **123.7 Service of notice – Posting.** Adequate and sufficient notice may be made by posting a copy
14 of the notice on the property in question if:

- 15 1. the identity or whereabouts of the owner, agent, person in control, former owner, or other
16 person responsible for the property is unknown, or
- 17 2. notice mailed under § 123.6 is returned unclaimed or refused or is designated undeliverable
18 by the post office for any other reason, and neither of the following sources can provide a
19 more accurate address:
 - 20 a. the tax records of the Bureau of Treasury Management, Collections Division, and
 - 21 b. the property registration files of the Department of Housing and Community
22 Development.

23 **123.8 Failure to comply with notice or citation.** If any person fails to comply with a violation
24 notice, condemnation notice, or citation, the Building Official:

- 25 1. may enforce the violation notice or condemnation notice by issuance of an environmental
26 citation as authorized by City Code Article 1, Subtitle 40 {"Environmental Control Board"},
- 27 2. may take whatever action is necessary and proper, including the institution of legal
28 proceedings, to compel compliance with the notice or citation or to enforce the penalty
29 provisions of this Code, and
- 30 3. subject to the notice requirements of § 123.8.1, may proceed to repair, rebuild, demolish, or
31 take any other action necessary to eliminate, in whole or in part, or make safe any nuisance,
32 blight, health hazard, or dangerous, insanitary, or unsafe condition that is the subject of the
33 violation notice, condemnation notice, or citation.

34 **123.8.1 Notice of intent to repair, etc.** Except as provided in § 123.8.2, before the Building
35 Official proceeds to repair, rebuild, demolish, or take any other action to eliminate or make safe
36 any nuisance, blight, health hazard, or dangerous, insanitary, or unsafe condition, a notice must
37 be posted on the front of the structure stating that the violation has not been rectified and that the

1 Building Official intends to undertake the necessary work and charge the expenses of that work
2 to 1 or more of the owner, agent, person in control, or former owner of the premises, as the case
3 may be. This notice must also be mailed or delivered to the home, business, or tax record
4 address of the owner, agent, person in control, former owner, or other person responsible for the
5 property, as the case may be, or their respective agents.

6 **123.8.2 Exception.** The notice required by §123.8.1 need not be given:

- 7 1. in the case of an emergency,
- 8 2. as provided in § 116.7 {"REMEDIAL ACTION BY BUILDING OFFICIAL"} of this Code for
9 unsafe structures, or
- 10 3. if the initial or any other prior notice or order issued by the Building Official informed
11 the recipient of the Building Official's authority to take corrective action and of the
12 recipient's right to request administrative review.

13 **123.8.3 Actions not an abatement, etc.** Actions taken by the Building Official under this
14 § 123.8 do not constitute an abatement or cancellation of the underlying notice or citation.

15 **123.9 Extension of time limit on notices.** The Building Official may extend the time within which
16 to comply with a condemnation notice or violation notice if, in the Building Official's judgment,
17 more time is needed to comply.

18 **123.10 Removal or defacement of posted notices.** No person may remove, deface, damage, or
19 change any notice, poster, or sign placed under this Code on any land, structure, or other object, until
20 the Building Official authorizes its removal.

21 **123.11 Notices for property owned by the City.** If the land, structure, or other object in violation
22 of this Code is owned by the City, the Building Official must notify:

- 23 1. the head of the bureau, department, commission, or other agency having jurisdiction over
24 that land, structure, or other object, AND
- 25 2. THE COUNCILMEMBER IN WHOSE DISTRICT THAT LAND, STRUCTURE, OR OTHER OBJECT LIES.

26 Section 124 Violation Reports

27 **124.1 Building Official to issue.** On application to the Department or to the Bureau of Liens, the
28 Building Official must issue a violation report for a particular property. The report MUST:

- 29 1. [must] state whether any violation or condemnation notices [have been issued] ARE OPEN for
30 that property, and
- 31 2. if [there has been] any ARE OPEN, [must] include a true copy of each notice.

32 Sections 125 to 127 {Reserved}

33 Section 128 Administrative and Judicial Review

34 **128.1 Right of review.** If any person is aggrieved by any notice, order, permit, penalty assessment,
35 or other act of the Building Official, the person may apply in writing to the Building Official for a
36 review.

1 **128.2 Application – General.** The application for review must:

- 2 1. be made within 10 days of the action for which review is sought,
- 3 2. set forth in full the reasons for the review, and
- 4 3. either be:
 - 5 a. mailed to the Building Official by certified or registered mail, return receipt

 - 7 b. delivered to the Building Official’s office and stamped received by the office.

8 **128.3 Application – Emergencies.** In the case of an emergency that presents substantial and
9 imminent danger to life, property, or the general public welfare, the time for requesting review may
10 be shortened or eliminated, as specified in the applicable notice, order, permit, penalty assessment, or
11 other act.

12 **128.4 When review to be held.** The requested review must be held within a reasonable time. If a
13 notice, order, permit, penalty assessment, or other act requires action within 10 days or less and an
14 application for review is made before the notice, order permit, penalty assessment, or time for other
15 act expires, the Building Official must promptly schedule a hearing, to be conducted in accordance
16 with § 128.5 {“HEARINGS”}.

17 **128.5 Hearings.** All hearings must be conducted in accordance with this § 128.5.

18 **128.5.1 Hearings to be public.** All hearings must be open to the public.

19 **128.5.2 Notification of complainants.** Before a hearing, the Building Official must notify all
20 persons who the Building Official knows are interested in the hearing of its scheduled date, time,
21 place, and purpose.

22 **128.5.3 Time and place for hearings.** Hearings must be held:

- 23 1. at the time the Building Official designates, and
- 24 2. in the office of the Building Official or at any other place the Building Official
25 designates.

26 **128.5.3.1 Postponements.** The Building Official may postpone a hearing only for
27 good cause shown.

28 **128.5.4 Hearing officer or panel.** A hearing officer or 3-person panel designated by the
29 Building Official presides at all hearings. The individual who issued the notice, order, permit,
30 penalty assessment, or other act being appealed may not serve as the hearing officer or as a
31 member of the panel.

32 **128.5.5 Rules for conducting hearings.**

33 **128.5.5.1 Building Official.** The Building Official may adopt general rules and regulations
34 for the proper conduct of hearings.

35 **128.5.5.2 Hearing officer or panel.** The hearing officer or panel may set requirements to
36 ensure a fair and expeditious hearing. The requirements set:

1. may include the holding of a pre-hearing conference, the briefing of certain issues, deadlines for the filing of motions, and other scheduling matters, but
2. may not be inconsistent with the general rules and regulations adopted by the Building Official.

128.5.6 Decision. Within 30 days after a hearing is completed, the hearing officer or panel must render a decision.

128.5.6.1 Form and contents. The decision must:

1. be in writing, and
2. contain separate statements of:
 - a. the findings of fact,
 - b. the conclusions of law, applying the relevant provisions of law to the findings of fact, and
 - c. the decision or order.

128.5.6.2 Distribution. A copy of the decision must be mailed or delivered to each party or that party's attorney of record.

128.5.6.3 Final administrative decision. A decision issued under this § 128 is a final administrative decision.

128.5.7 Records. The Department must keep a complete record of all papers filed in connection with any hearing, together with a copy of the written decision.

128.5.8 Transcript. The costs of preparing a hearing transcript must be paid by the party requesting the transcript.

128.6 Judicial review. A party aggrieved by the decision may seek judicial review of that decision by petition to the Circuit Court for Baltimore City in accordance with the Maryland Rules of Procedure. A party to the judicial review may appeal the court's final judgment to the Court of Special Appeals in accordance with the Maryland Rules of Procedure.

128.6.1 Proceedings not stayed. A judicial review or appeal does not stay any criminal or equitable proceedings or prevent the Building Official from pursuing any other action or enforcement procedure authorized by law.

18 use are classified as Group U, Utility and Miscellaneous Structures.

28 ability, acrobatic stunts, trained animal acts, clowning, and other similar performances, mechanical
29 rides, or other amusement devices to which the public is admitted, and includes any temporary stands
30 or facilities for selling or dispensing products for human consumption in connection with these uses.

31 **426.2 [425.2] Scope.** This section covers regulations for circuses and carnivals that are not provided
32 for in other sections of this Code.

33 **426.3 [425.3] Permit required.** Before any person may begin to set up any structure, appliance, or
34 equipment for a circus or carnival, the person must obtain the appropriate permit from the Building
35 Official.

36 **426.3.1 [425.3.1] Application for permit.** The application for the permit must be:

- 37 1. filed at least ~~10~~ 30 days before the opening date of the circus or carnival, and
- 38 2. signed by a responsible person or official acting for the applicant.

23 amount that the City's Office of Risk Management considers sufficient, to:

- 24 1. insure the applicant, and name the City as an additional insured, against liability for damage
25 or injury to property or person, including death, due to faulty equipment or negligence, and
- 26 2. indemnify the City against any suit, loss, claim, damages, or expense to which the City is
27 subjected because of any damage or injury to property or person, including death, or injury to
28 any public highway or other public property done by or in connection with the transportation,
29 erection, operation, maintenance, or supervision of a mechanical ride or device.

30 **426.5 [425.5] Financial responsibility.** Before a permit may be issued, the applicant must furnish
31 proof of financial responsibility, in the form of a certificate of insurance from an insurer authorized
32 to do business in this State. The certificate of insurance must state that the circus or carnival is
33 insured against any legal liability (other than that covered by [§ 425.4] § 426.4), caused by accidents
34 or otherwise and resulting in damage or injury to property or person, including death, as a
35 consequence of the ownership, operation, or maintenance of the circus or carnival or otherwise in
36 any way connected with the circus or carnival. The insurance must be for at least the amount that the
37 City's Office of Risk Management considers sufficient to protect the public, and must name the City
38 as an additional insured. Additionally, the insurance must be in an amount that the City's Office of
39 Risk Management considers sufficient to:

10 ownership, operation, or maintenance of the circus or carnival or otherwise in any way connected
11 with the circus or carnival. If the applicant is a nonresident corporation, the corporation, in
12 addition to complying with all other requirements of this Code, must submit with its application a
13 certificate from the Maryland Department of Assessments and Taxation certifying that it is a
14 corporation authorized to do business in this State.

15 **426.5.2 [425.5.2] Nonprofit entities excepted.** This [§ 425.5] § 426.5 does not apply to any
16 applicant that is a church, school, charitable organization, veterans' organization, or other
17 nonprofit organization.

18 **426.6 [425.6] Zoning requirements.** The provisions of the BALTIMORE CITY Zoning Code that

28 (9.14 m) wide, and
- 29 3. be at least 10 feet (3.05 m) wide for a length of up to 100 feet (30.48 m), plus an
30 additional 2½ feet (0.76 m) in width for each additional 100 feet (30.38 m) or fraction
31 of 100 feet (30.38 m) in length.

32 **426.7.2 [425.7.2] Side or branch aisles.** Side or branch aisles that are open at both ends must
33 be at least 6 feet (1.83 m) wide for a length of up to 50 feet (15.24 m), plus an additional 1 foot

1211.3.2 **Occupants' responsibilities.** For carbon monoxide alarms located in a tenant-occupied dwelling unit, the tenant must:

1. test and maintain the alarms according to their manufacturers' guidelines, and
2. replace batteries as needed.

1211.3.3 **Required locations.** A carbon monoxide alarm must be installed in a central location outside of each sleeping area in the dwelling.

1211.3.4 **Method of installation.** Installation of an alarm must be by attachment to a wall or ceiling in accordance with:

1. National Fire Protection Association (NFPA) 720, Standard for the Installation of Household Carbon Monoxide (CO) Warning Equipment in Dwelling Units; or
2. the manufacturer's recommendations.

1211.4 Power source.

1211.4.1 **Dwellings subject to State law.** For a newly constructed dwelling to which State Public Safety Article Title 12 {"Building and Material Codes"}, Subtitle 11 {"Carbon Monoxide Alarms"} applies, the carbon monoxide alarm must be wired into an alternating current (AC) powerline with battery backup.

1211.4.2 **Other dwellings.** For an existing or newly constructed dwelling to which State Public Safety Article Title 12, Subtitle 11, does not apply, the alarm must be:

1. hardwired into an alternating current (AC) powerline, with battery backup,
2. plugged into an electrical outlet not controlled by a switch, with battery backup, or
3. battery-powered.

1211.5 **Light signal for hearing impaired.** The owner of a rental unit must provide a carbon monoxide alarm that is designed (and has been tested and certified by an approved testing laboratory) to alert persons with hearing impairments, if the tenancy is occupied by a person who is hearing impaired and the tenant has asked for the alarm in writing by certified or registered mail.

22 building may be discharged so as to run or flow over any sidewalk, footway, or any adjoining
23 property, except from window sills, copings, or cornices that project no more than 1 foot (305
24 mm).

In investigating new materials, appliances, and equipment, the Building Official must consider the factors listed in NEC [§ 110-3] § 110.3 {"EXAMINATION, IDENTIFICATION, INSTALLATION, AND USE OF EQUIPMENT"}.

Section 2702 Emergency and Standby POWER SYSTEMS

2702.1 Installation. Emergency and standby power systems must be installed in accordance with the National Electrical Code.

14 hazard or other hazardous condition, the work may be undertaken, even before a permit is issued, by:

- 15 1. a master plumber, or
- 16 2. within the scope of his or her license:
 - 17 a. an on-site utility contractor, or
 - 18 b. a gas fitter.

19 **2902.4.1 Notice and subsequent permit.** A master plumber, contractor, or gas fitter who
20 performs emergency work under this section must:

- 21 1. promptly notify the proper City authorities of the emergency, and
- 22 2. within a reasonable time, obtain a permit for the work.

23 Section 2903 *{Reserved}*

24 Section 2904 Licensing Requirements

25 **2904.1 Licenses and supervision required.** Except as otherwise provided in this section, no person
26 may provide plumbing services or otherwise engage in any plumbing work unless:

- 27 1. the person is licensed to do so in accordance with State law, and
- 28 2. the services and work are done by or under the direct supervision of an insured, licensed
29 master plumber.

30 **2904.1.1 On-site utilities work.** On-site utility work, as defined in City Code Article 13,
31 § 18-1, may be done by or under the direct supervision of an on-site utility contractor licensed by
32 the City.

1 Section 3108 Telecommunication and Broadcast Towers

2 3108.1 General *{As in IBC}*

3 3108.2 Location and access. *{As in IBC}*

4 3108.3 Aircraft warning lights. Radio and television towers must be equipped with aircraft
5 warning lights that comply with Federal Aviation Administration requirements.

6 Section 3109 Swimming Pool Enclosures and Safety Devices

7 3109.1 General. Swimming pools must comply with the requirements of:

- 8 1. this section,
- 9 2. other applicable sections of this Code,
- 10 3. all regulations of the Baltimore City Health Department, and
- 11 4. all location and other applicable provisions of the Baltimore City Zoning Code.

12 3109.2 to 3109.5 *{As in IBC}*

13 Section 3110 Automatic Vehicular Gates *{As in IBC}*

14 SECTION 3111 SOLAR PHOTVOLTAIC PANELS/MODULES *{AS IN IBC}*

15 Section 3112 [3111] Parking Lots, Driveways, and Other Paved Surfaces

16 3112.1 [3111.1] Section inapplicable to special-event parking. This [§ 3111] § 3112 does not
17 apply to special-event parking lots operating under and in compliance with City Code Article 15,
18 Subtitle 13 {"Parking facilities – Special-Event Parking Lots"} as long as the lot complies with all
19 other requirements applicable to the lot's principal occupancy, use, or structure.

20 3112.2 [3111.2] Driveway entrances.} All driveway entrances located on a public right-of-way
21 must be constructed in accordance with the rules and regulations of the Department of ~~Public Works~~
22 TRANSPORTATION AND THE PERMIT REQUIREMENTS OF THE DEPARTMENT OF GENERAL SERVICES.

23 3112.3 [3111.3] Surface paving. Parking lots, parking pads, driveways, and private roads must be
24 paved with asphalt, brick, concrete, macadam, or stone block. Permeable paving systems may be
25 utilized in accordance with the rules and regulations of the Department of Public Works. All paving
26 must be able to support the design loads for the proposed vehicular traffic.

27 3112.4 [3111.4] Parking spaces. The size, layout, and arrangement of parking spaces must comply
28 with:

- 29 1. the BALTIMORE CITY Zoning Code,
- 30 2. the Maryland State Accessibility Code, and
- 31 3. the rules and regulations of the City Planning Commission.

32 3112.5 [3111.5] Curbs or bumpers. Curbs or bumpers must be installed for all parking spaces.
33 Each curb or bumper must be:

Council Bill 12-0123

- 1 1. made of concrete, wood, or an approved metal wheel stop,
- 2 2. at least 6 inches (152 mm) high and 8 inches (203 mm) wide,
- 3 3. securely fixed in place, and
- 4 4. located:
 - 5 a. at least 4 feet (1.22 m) from the parking lot perimeter, or
 - 6 b. for parking spaces that are parallel to the perimeter of the parking lot,
 - 7 at least 2 feet (0.61 m) from the perimeter.

8 **3112.6 [3111.6] Surface drainage.** Storm drainage off paved surface areas, such as parking lots,
9 playgrounds, and plazas, must be properly conveyed to paved alleys, paved streets, or other approved
10 water courses.

11 **3112.6.1 [3111.6.1] Limitations.** No drainage may be discharged:

- 12 1. so as to run or flow over any sidewalk or footway, except at a driveway with a depressed
13 curb, or
- 14 2. across any adjoining property.

15 **3112.6.2 [3111.6.2] Methods.** Drainage must be piped to a storm drain, to the street or alley, to
16 a paved swale, or to another approved water course. The installation of piping, connections to
17 storm drains, etc., must be made in accordance with the plumbing regulations of Chapter 29
18 {"PLUMBING SYSTEMS"} of this Code.

19 Section 3113 [3112] Piers and Marinas

20 **3113.1 [3112.1] General.** All piers, marinas, and related structures constructed or demolished along
21 the shoreline of the City must comply with the requirements of this [§ 3112] § 3113, in addition to all
22 other applicable provisions of this Code.

23 **3113.2 [3112.2] Plans and specifications.** All proposed work for piers and marinas requires plans
24 and specifications that illustrate, describe, and specify the proposed work in sufficient detail and
25 clarity.

26 **3113.3 [3112.3] Approvals.** Before a building permit may be issued for the construction or
27 demolition of a pier, marina, or related structure, the work must be approved by:

- 28 1. the U.S. Army Corps of Engineers (Baltimore District),
- 29 2. the State of Maryland,
- 30 3. the Division of Construction and Buildings Inspection,
- 31 4. the Baltimore City Fire Department, and
- 32 5. the Baltimore City Department of Public Works.

33 **3113.4 [3112.4] Design.** All shoreline and offshore free-standing piers, with or without buildings,
34 must be designed in accordance with:

Council Bill 12-0123

- 1 1. the design manuals of the Federal Emergency Management Agency, and
- 2 2. the requirements of this Code.

3 **3113.5 [3112.5] Structural design for piers.** Minimum live load requirements are as follows:

- 4 1. for static or fixed piers or marinas for light duty uses, 60 pounds per square foot, and
- 5 2. for heavy duty live loads and for structures constructed on piers, as required by Chapter 16
- 6 {“STRUCTURAL DESIGN”} of this Code.

7 **3113.6 [3112.6] Structures on piers.** Every structure that is constructed on a pier, wharf, dock,
8 bulkhead, breakwater, piles, or other similar structure must comply with this [§ 3112] § 3113 and all
9 other applicable provisions of this Code and other law.

10 **Section 3114 [3113] Fences**

11 **3114.1 [3113.1] Location.** A fence may be built only on the property of the owner of the fence.
12 However, if the owners of adjoining property agree to build a fence on the property line between
13 them, they may do so if they both submit, with the application for the permit, a written statement of
14 their agreement.

15 **3114.2 [3113.2] Height.** Except as otherwise specified in this [§ 3113.2] § 3114.2, the height of a
16 fence may not exceed 42 inches (1067 mm), measured on the high side.

17 **3114.2.1 [3113.2.1] Enclosing dwellings.** Fences enclosing dwellings may be as high as, but
18 may not exceed, 6 feet (1.83 m) if located in side or rear yards.

19 **3114.2.2 [3113.2.2] Enclosing certain other buildings.** Fences enclosing buildings used for
20 public assembly, private assembly, institutions, offices, commercial storage, or industrial
21 occupancies may be as high as, but may not exceed, 8 feet (2.44 m).

22 **3114.2.3 [3113.2.3] Special purposes.** For special purposes like protection around dangerous
23 places, highly hazardous operations, or athletic fields, and in similar cases where a high fence is
24 necessary for the safety of the public, fences may be higher than 8 feet (2.44 m) to the extent
25 specially authorized by the Building Official.

26 **3114.3 [3113.3] Construction.** Fences may be built of any material or construction that is permitted
27 in this Code for exposed structures. However, all fences must be designed and constructed, in
28 accordance with the applicable structural provisions of this Code, to resist from any direction a
29 horizontal force of 20 pounds per square foot, applied normal to and over either the gross area of the
30 fence or the net area of the fence plus 50% of the gross area, whichever is less.

31 **3114.3.1 [3113.3.1] Wood fences.** The posts for wood fences must be:

- 32 1. locust, heart cedar, or any other wood that will resist decay underground,
- 33 2. any wood that has been treated in accordance with this Code, or
- 34 3. any good timber set in concrete.

35 **3114.3.2 [3113.3.2] Wire fences.** Wire fences must be constructed with wire mesh substantially
36 fabricated and constructed so as to resist a nominal horizontal load of 500 pounds without
37 deflecting more than 6 inches (152 mm). The posts for wire fences must be metal posts set in
38 concrete, properly designed masonry posts, or wood posts of the type required for wood fences.

Council Bill 12-0123

1 **3114.3.3 [3113.3.3] Metal fences.** Metal fences must be of a substantial design and construction
2 approved by the Building Official. The posts for metal fences must be concrete, masonry, or
3 metal set in concrete or masonry.

4 **3114.3.4 [3113.3.4] Masonry fences.** Masonry fences must be of reinforced concrete or other
5 masonry and must be designed and constructed in accordance with the requirements governing
6 reinforced concrete or freestanding masonry walls. All masonry fences must extend at least 2
7 feet (0.61 m) into the ground.

8 **3114.3.5 [3113.3.5] Combination fences.** Fences that consist of 2 or more kinds of materials
9 may be built as long as all applicable requirements of this Code for those materials and
10 construction are met. The total aggregate height of a combination fence must be used in
11 determining the height limitations for that fence.

12 **3114.4 [3113.4] Sharp points, projections, etc.** No fence may have any projecting sharp points,
13 jagged edges, or other projections that can injure persons or animals coming in contact with the
14 fence.

15 **3114.4.1 [3113.4.1] Fence tops.** No fence less than 3 feet 6 inches (1.07 m) high may have any
16 sharp pickets or vertical pointed objects at the top. Barbed wire or other approved retarding
17 material or construction may be placed on the top of any fence that is more than 6 feet 9 inches
18 (2.06 m) high, unless the barbed wire or other retarding material will create a highly hazardous
19 condition.

20 **3114.4.2 [3113.4.2] Razor wire.** Razor wire may not be used anywhere in any fence.

21 **3114.5 [3113.5] Maintenance.** Every fence must be maintained in good repair by its owner. The
22 Building Official may determine the sufficiency of any fence and the amount and character of repairs
23 required to make it safe.

24 **3114.6 [3113.6] Nonconforming fences.** Any existing fence that was compliant when erected but
25 does not comply with the requirements of this [§ 3113] § 3114 is permitted to continue to exist and
26 be repaired at any time, unless the fence has deteriorated more than 50%. All nonconforming fences
27 that have deteriorated more than 50% or beyond repair must be removed or reconstructed in
28 accordance with the requirements of this Code.

29 **Section 3115 [3114] Radio and Television Antennas**

30 **3115.1 [3114.1] Aircraft warning lights.** Radio and television antennas located on a high rise
31 building or on a high terrain feature must comply with Federal Aviation Administration requirements
32 for aircraft warning lights.

33 **Section 3116 [3115] Lightning Protection**

34 **3116.1 [3115.1] General.** Lightning protection for buildings and structures must comply with NFPA
35 780.

36 **Chapter 32. Encroachments into the Public Right-of-Way**

37 **Section 3201 General**

38 **3201.1 Scope.** *{As in IBC}*

39 **3201.2 Measurement.** *{As in IBC}*

Council Bill 12-0123

1 **3201.3 Other laws.** This Chapter does not permit anything that is otherwise prohibited or regulated
2 by any law governing the use of public property.

3 **3201.3.1 Permission needed for encroachments.** No person may use, encroach on, or connect
4 to any street, highway, alley, or other public right-of-way for any purpose unless that person first
5 obtains permission to do so by:

- 6 1. an ordinance of the Mayor and City Council,
- 7 2. a minor privilege permit issued by or under the authority of the Board of Estimates, or
- 8 3. an appropriate permit issued by the Department of General Services.

9 **3201.4 Drainage generally.** Drainage may not be discharged from private property on to the public
10 right-of-way except through piping to a storm drain, to a street or alley, or to some other water course
11 approved by the Department of Public Works. Drainage may not be discharged to flow over the
12 surface of any public sidewalk.

13 Section 3202 Encroachments

14 **3202.1 Encroachment below grade.** *{As in IBC}*

15 **3202.2 Encroachment above grade and below 8' in height.** *{As in IBC}*

16 **3202.2.1 Steps.** Steps may not project more than any 1 or another of the following distances:

- 17 1. 1/4 of the width of a public sidewalk on which the steps are located,
- 18 2. 4 feet (1219 mm) into a public sidewalk, or
- 19 3. any distance that leaves a clear public sidewalk of less than 4 feet (1219 mm).

20 **3202.2.2 Architectural features.** *{As in IBC}*

21 **3202.2.3 Awnings.** *{As in IBC}*

22 **3202.3 Encroachment 8' or more above grade.** *{As in IBC}*

23 **3202.4 Temporary encroachments.** *{As in IBC}*

24 **3202.5 Unauthorized encroachment.** In this § 3202.5, “unauthorized encroachment” means any
25 building, structure, projection, object, or other thing that has been placed, constructed, or installed
26 on or connected to a public right-of-way without appropriate permission, as outlined in § 3201.3.1
27 {“PERMISSION NEEDED...”}.

28 **3202.5.1 Removal of unauthorized encroachments.** On notice from the Building Official or
29 the Director of General Services, the owner of any unauthorized encroachment must
30 immediately:

- 31 1. remove the encroachment, or
- 32 2. obtain appropriate permission for its continuation.

Council Bill 12-0123

Chapter 33. Safeguards During Construction

Section 3301 General

3301.1 to 3301.2 *{As in IBC}*

3301.3 Prohibited hours. No site work, demolition work, pile driving work, or construction work is permitted between 7:00 p.m. and 7:00 a.m., if that work or any part of a premises in or on which the work is to be done is within 300 feet (91.44 m) of any dwelling.

3301.3.1 Exception. This § 3301.3 does not apply to an emergency operation that has been specifically approved by the Building Official.

Section 3302 Construction Safeguards

3302.1 Remodeling and additions. Required exits, existing structural elements, fire protection devices, and sanitary safeguards must be maintained at all times during remodeling, alterations, repairs, or additions to any building or structure.

Exceptions:

1. When these required elements or devices are themselves being remodeled, altered, or repaired, adequate substitute provisions must be made.
2. These requirements do not apply if the existing building is not occupied.

3302.2 Waste and debris. All sites for new construction or for remodeling, alterations, repairs, or additions, and all abutting sidewalks, gutters, and alleys, must be properly maintained and kept free of accumulated trash, garbage, waste, or debris, including construction waste or debris, and of any object or condition that constitutes a nuisance. Removal of all trash, garbage, waste, and debris must be done in a manner that prevents injury or damage to persons, adjoining properties, and public rights-of-way.

3302.3 FIRE SAFETY DURING CONSTRUCTION. *{AS IN IBC}*

Section 3303 Demolition

3303.1 to 3303.3 *{As in IBC}*

3303.4 Filling required. Except as otherwise specified in this § 3303.4, where a structure has been demolished or removed, the vacant area must be filled and maintained to the existing grade or otherwise in accordance with City law and seeded.

3303.4.1 Cellar floors. All basement and cellar floors must be removed or completely broken up before any filling materials are used.

3303.4.2 Exception. The Building Official may waive the filling requirements of this § 3303.4 for up to 3 months if:

1. the Building Official receives satisfactory evidence that construction of a new building or structure will begin on the site within 3 months of the demolition or removal, and
2. the site is protected with barriers that comply with § 3306.5 {"BARRIERS"} of this Code.

3303.5 to 3303.7 [3303.6] *{As in IBC}*

Council Bill 12-0123

1 **3303.8 [3303.7] Notice to adjoining owners and others.** A permit to demolish a structure may not
2 be issued unless:

- 3 1. all notices required by §§ 105.9 {"SPECIAL REQUIREMENTS FOR DEMOLITION OR MOVING"}
4 and 3307.1 {"PROTECTION REQUIRED"} of this Code have been given, and
- 5 2. copies of the notices are submitted with the permit application.

6 **3303.9 [3303.8] Demolition contractor's license.** Except as otherwise specified in this [§ 3303.8]
7 § 3303.9, no person may engage in the demolition of any structure without first obtaining a
8 demolition contractor's license from the Building Official.

9 **3303.9.1 [3303.8.1] Prerequisites.** Every contractor applying for a new license or for the
10 renewal of a license must:

- 11 1. provide the Building Official with the full name, phone number, address, and (if
12 available) email address of the contractor's business, and
- 13 2. provide the Building Official with a copy of a liability insurance policy that complies
14 with [§ 3303.9] § 3303.1 of this Code.

15 **3303.9.2 [3303.8.2] Term; fees.** A demolition contractor's license expires on December 31 of
16 each year. The license may be renewed annually, on or before December 31, on payment of the
17 renewal fee. The license fees are as set by the Building Official with the approval of the Board
18 of Estimates.

19 **3303.9.3 [3303.8.3] Change of name or address.** A licensee must immediately notify the
20 Building Official of any change in the name, phone number, address, or email address of the
21 licensee's business.

22 **3303.9.4 [3303.8.4] Use of license by other.** A licensee may not allow his or her name to be
23 used by another person for the purpose of obtaining permits or for doing any demolition work
24 under the licensee's license.

25 **3303.9.5 [3303.8.5] Exception.** The Building Official may waive the requirements of this
26 [§ 3303.8] § 3303.9 if the structure to be demolished is a miscellaneous structure as described in
27 § 312 {"UTILITY, MISCELLANEOUS GROUP U"} of this Code.

28 **3303.9.6 [3303.8.6] Enforcement.** A violation notice is not a prerequisite to the enforcement of
29 this [§ 3303.8] § 3303.9 by any appropriate legal proceeding. Penalties will be assessed in
30 accordance with § 114 {"VIOLATIONS"} of this Code.

31 **3303.9.7 [3303.8.7] Debarment on conviction.** Any person convicted of a violation of this
32 [§ 3303.8] § 3303.9 is, in addition to any other penalty that might be imposed:

- 33 1. prohibited from performing demolition work without first obtaining a new license, and
- 34 2. is ineligible to receive a new license for ~~6 months~~ 1 YEAR.

35 **3303.10 [3303.9] Demolition insurance.** The licensee must have an insurance policy that complies
36 with the minimum requirements of this [§ 3303.9] § 3303.10.

37 **3303.10.1 [3303.9.1] Coverage.** The policy must provide coverage for all operations for which a
38 permit might be sought. The minimum coverage requirements are:

Council Bill 12-0123

- 1 1. ~~\$250,000~~ \$500,000 for damages (including damages for care and loss of services)
2 because of bodily injury (including death at any time resulting from bodily injury), per
3 person, per incident,
- 4 2. ~~\$750,000~~ \$1,000,000 for damages (including damages for care and loss of services)
5 because of bodily injury (including death at any time resulting from bodily injury)
6 sustained by more than 1 person per incident, and
- 7 3. ~~\$100,000~~ \$250,000 for injury to or destruction of property of others per incident.

8 **3303.10.2 [3303.9.2] Prohibited exclusions.** The policy may not contain:

- 9 1. any “collapse hazard” exclusion,
- 10 2. any exclusion that would prohibit the contractor from performing the demolition
11 operations in accordance with this Code and the normal procedures of the industry, or
- 12 3. any exclusion that would create an undue risk to the City or to the health, safety, and
13 welfare of the general public.

14 **3303.10.3 [3303.9.3] Cancellation.** The terms of policy must provide either:

- 15 1. that the policy may not be canceled during the duration of the operations to be
16 performed, or
- 17 2. that the Building Official will be notified in writing, at least 15 days before the policy is
18 canceled.

19 **3303.11 [3303.10] to 3303.12 {Reserved}**

20 **3303.13 Demolition permits.** Each application for a demolition permit must:

- 21 1. comply with § 105 {“PERMITS”} of this Code,
- 22 2. except as provided in § 3303.13.1, be accompanied by a certificate of insurance that
23 evidences compliance with [§ 3303.9] § 3303.10, and
- 24 3. be accompanied by an affidavit to the Building Official that all contracts and other
25 arrangements complying with this Code have been made.

26 **3303.13.1 Alternative certificate of continuing insurance.** Instead of providing a separate 27 certificate for each permit, a contractor may provide one general certificate of continuing 28 insurance, as long as the certificate evidences:

- 29 1. the required coverage for all work to be performed by the contractor, and
- 30 2. the insurer’s obligation to notify the Building Official, in writing, at least 15 days
31 before the policy is canceled.

32 **3303.14 to 3303.15 {Reserved}**

33 **3303.16 Methods of demolition.** The following methods must be used for the demolition of a 34 structure:

Council Bill 12-0123

- 1 1. The demolition must be performed in approximately the reverse order in which the structure
2 was erected. Where unusual conditions exist, the Building Official may authorize a different
3 method.
- 4 2. Structural elements must be carefully disassembled to avoid collapse.
- 5 3. Heavy pieces of stone or other heavy and bulky materials or equipment must be carefully
6 handled in accordance with [§§ 3304 through 3312 of] this Code.

7 **3303.17 Use of explosives.** The use of explosives is generally prohibited. Explosives for
8 demolition by implosion may be used by special permit from the Building Official.

9 **3303.18 Partial Demolition.** Building elements that become exposed as result of a partial
10 demolition must be properly finished, braced, or otherwise made safe.

11 **3303.19 to 3303.20 {Reserved}**

12 **3303.21 Removal of debris.** The requirements of this section are in addition to those of § 3302.2
13 {"WASTE AND DEBRIS"}.

14 **3303.21.1 General requirements.** Debris on upper floors must be lowered to ground level:

- 15 1. in receptacles, by elevators or hoists, or
- 16 2. in tight and completely enclosed chutes.

17 **3303.21.2 Chute requirements.** No chute used for this purpose may extend in an unbroken line
18 that is more than 25 feet (7.62 m) without suitable barriers to prevent debris from falling too fast.
19 Each chute must be equipped with a proper gate or stop at the bottom to control the flow of
20 materials from the chute.

21 **3303.22 {Reserved}**

22 **3303.23 Disposition of recyclable debris.** Whenever recyclable debris to be cleared from a site
23 exceeds 5 tons, at least 30% of that recyclable debris must be immediately transported to a licensed
24 recycling facility.

25 **3303.23.1 "Recyclable debris" defined.** In this section, "recyclable debris" means materials
26 that:

- 27 1. if not recycled, would become solid waste for disposal in a solid waste
28 acceptance facility, and
- 29 2. may be collected, separated, or processed and returned to the marketplace in
30 the form of raw materials or products.

31 **3303.24 to 3303.25 {Reserved}**

32 **3303.26 Correction of injurious conditions.** This section applies to any demolition contractor who:

- 33 1. performs any demolition work that creates a condition that violates this Code or a condition
34 that might be injurious to the general public or adjoining to adjoining properties, and
- 35 2. refuses or fails to correct the condition in the manner and time required by this Code.

Council Bill 12-0123

1 **3303.26.1 Correction by Building Official.** If the contractor refuses or fails to correct the
2 condition or if an emergency occurs as a result of the condition, the Building Official may
3 correct the condition or perform any other operations necessary to bring the demolition
4 operations into compliance with this Code. All work the Building Official performs under this
5 section is at the expense of the contractor.

6 **3303.26.2 Contractor not relieved of responsibility.** The Building Official's performance of
7 any work under this section does not relieve the contractor from responsibility for all work
8 performed by the contractor. Any remedies or penalties provided in this section are in addition
9 to any other remedies or penalties provided by law.

10 **3303.27 Limits of liability.** The liability of any contractor for materials furnished or work done
11 under this Code and the liability of the contractor's surety does not extend to defects in materials or
12 workmanship discovered more than 12 months after the completion of the work. The contractor and
13 surety are responsible to the City to correct all defects discovered during this 12-month period and
14 about which they were notified in writing.

15 **3303.28 Owner's responsibility.** Notwithstanding the limited liabilities of the contractor and the
16 surety, the owner of the property is responsible at all times to the City to correct any defects in the
17 operations performed on his or her property.

18 **3303.29 Penalty for violation.** On a contractor's refusal or failure to correct any violation, the
19 contractor's license and all outstanding work permits are automatically suspended. The suspension
20 continues until the violation is corrected.

21 Section 3304 Site Work *{As in IBC}*

22 Section 3305 Sanitary [Facilities] *{AS IN IBC}*

23 **[3305.1 Facilities required.** Sanitary facilities must be provided during construction, remodeling,
24 or demolition activities in accordance with the National Standard Plumbing Code.]

25 Section 3306 Protection of Pedestrians *{As in IBC}*

26 Section 3307 Protection of Adjoining Property

27 **3307.1 Protection required.** *{As in IBC}*

28 **3307.2 Shared elements – General.** Repairs to elements shared by a demolished or moved
29 structure and an adjoining structure must comply with all applicable provisions of this Code.

30 **3307.3 Shared elements – Walls.** Party walls must be repaired and finished by the owner of
31 the demolished or moved structure. The repairs must include:

- 32 1. restoration or replacement of any flashing on adjoining property that has been broken
33 or damaged during the operations,
- 34 2. removal of all plaster from the exposed side of the wall, and
- 35 3. cleaning and finishing the wall with approved waterproof material.

1 Section 3314 [3313] Rodenticide Procedure

2 **3314.1 [3313.1] Certification required.** Before any structure may be demolished, moved to
3 another site, or substantially rehabilitated, the applicant for a permit must provide certification from a
4 pesticide applicator licensed by the State of Maryland that all areas of the structure and its lot are
5 free from rodent infestation. A certification of treatment and abatement of all infestation must
6 accompany the permit application.

7 **3314.2 [3313.2] Treatment required.** Structures or lots found to be infested must be treated by a
8 licensed pesticide applicator before demolition, moving, or rehabilitation

9 SECTION 3315 [3314] UNSAFE WALLS

10 **3315.1 [3314.1] Presumption.** For purposes of this [§ 3314] § 3315, any load-bearing wall that is
11 cracked or bowed and any 4-inch load-bearing wall is considered a structurally unsafe wall unless
12 certified to be safe by a professional structural engineer licensed in Maryland.

13 **3315.2 [3314.2] Removal or correction required.** Any structurally unsafe wall that remains after
14 the demolition or moving of a structure must be:

- 15 1. removed and replaced as required by all applicable sections of this Code, or
- 16 2. in the case of a party wall, corrected as provided in [§ 3314.3] § 3315.3.

18 **3315.3 [3314.3] Party walls.** If the structurally unsafe wall that remains is a party wall, the owner of
19 the structure being demolished or removed must:

- 20 1. remove all or any part of the wall that the Building Official considers dangerous, and
- 21 2. reconstruct and do all other necessary work to properly enclose the adjoining structure.

22 Section 3315 Operations Not to Cause Nuisance

23 **3315.1 Scope.** This section applies to all operations that involve:

- 24 1. moving or demolishing any structure, or
- 25 2. removing any machinery or equipment from any structure to be moved or demolished.

26 **3315.2 Work to avoid nuisance.** All operations of the sort described in § 3315.1 must be
27 conducted so that:

- 28 1. no material, object, or thing is allowed to fall in or on any structure or premises or any alley
29 or other public way,
- 30 2. all materials, objects, and things are well wetted down or otherwise treated as needed
31 to prevent dust or other airborne debris, and
- 32 3. no nuisance is otherwise created in the vicinity of the operations.

33 **3315.3 Stop-work order.** If any operation violates these requirements, the Building Official must
34 issue a stop-work order. Work may resume only after the violation has been corrected and measures
35 taken to prevent a recurrence.

Chapter 36. “Visitability” Requirements for Publicly Assisted Dwellings

Section 3601 Scope

3601.1 General. This Chapter applies to every single-family dwelling, whether detached, semi-detached, or attached, and to all ground-floor dwelling units of any 2-family dwelling or of any multiple-family dwelling that contains 4 or fewer dwelling units, that:

1. is newly constructed on a vacant lot, and
2. receives funding or other assistance from the City or any City agency (including the Housing Authority of Baltimore City) by any one of the following methods:
 - a. a building contract or similar agreement that involves any Federal, State, or City funds,
 - b. acquisition, by gift, purchase, lease, or otherwise, of any real property for less than its appraised value, as determined by a certified appraiser,
 - c. preferential tax treatment, such as payments in lieu of taxes, tax increment financing, or similar benefit,
 - d. bond proceeds or issuance assistance, a loan, or similar financial benefit,
 - e. receipt under City authority of Federal or State construction funds, including Community Development Block Grant funds, and
 - f. except as otherwise specified in this section, receipt of any other form of funding or financial benefit from the City or a City agency.

1 **3601.2 Exclusions.** This Chapter does not apply to:

- 2 1. additions to or remodelings of existing buildings, or
- 3 2. new construction for which City funding or assistance is limited to either or both:
 - 4 a. a property tax credit under City Code Article 28, § 10-5 {"Newly constructed
 - 5 buildings"}, and
 - 6 b. waiver of a City lien on property where the lien exceeds the value of the property.

7 **Section 3602 Accessible Entry**

8 **3602.1 Requirements.** Every dwelling that is subject to this Chapter must provide at least 1
9 entrance that:

- 10 1. is accessible to, and usable by, a person with a mobility disability,
- 11 2. does not include steps,
- 12 3. has a level change (including any level change at threshold) that does not exceed ½ inch and,
13 if the level change exceeds ¼ inch, is beveled, and
- 14 4. is located on a continuous unobstructed path that, through the use as necessary or appropriate
15 of curb ramps, parking access aisles, walks, ramps, elevators, lifts, and the like:
 - 16 a. connects the lot entrance to the dwelling entrance, and
 - 17 b. can be negotiated by a person with a disability who uses a wheelchair, by a person
18 with a disability who does not require use of a wheelchair, and by a person without a
19 disability.

20 **Section 3603 Accessible Interior**

21 **3603.1 "Entry level" defined.** In this § 3603, "entry level" means the level at which an accessible
22 entrance is provided under § 3602.1 {"REQUIREMENTS"}.

23 **3603.2 Interior doors.** On the entry level of the dwelling, each door designed to allow passage
24 must have an unobstructed opening of at least 32 inches when the door is open at a 90-degree angle.

25 **3603.3 Environmental controls.**

26 **3603.3.1 "Environmental control" defined.** In this § 3603.3, "environmental control" means
27 any switch or device that controls or regulates lights, temperature, fuses, fans, doors, security
28 systems, or similar features included in the construction of the dwelling unit.

29 **3603.3.2 Requirements.** On the entry level of the dwelling, each environmental control must be
30 located:

- 31 1. no higher than 48 inches above the floor and no lower than 15 inches above the floor,
32 and
- 33 2. if an environmental control is located directly above a counter, sink, or appliance, no
34 higher than 3 inches above the counter, sink, or appliance.

1 **3603.4 Habitable space.** The entry level of the dwelling must contain at least 1 interior room that:

- 2 1. has an area of not less than 108 sq. ft., and
- 3 2. contains no side or dimension narrower than 9 feet.

4 **3603.5 Bathroom.** The entry level of the dwelling must contain at least 1 bathroom that contains:

- 5 1. a toilet,
- 6 2. a sink,
- 7 3. reinforced walls at the toilet, to allow for future installation of grab bars, and
- 8 4. the following minimum dimensions:
 - 9 a. 30"-by-48" of clear floor space outside of the door swing,
 - 10 b. 30"-by-48" of clear floor space parallel to and centered on the sink, and
 - 11 c. 48"-by-56" of clear floor space at the toilet for a side approach.

12 **Section 3604 Waivers**

13 **3604.1 General.** The Building Official may grant a waiver from one or more of the requirements of
14 this Chapter if:

- 15 1. the cost of grading the terrain to meet the requirement is disproportionately expensive in
16 relation to the value of the dwelling,
- 17 2. the width of the lot is less than 16 feet, or
- 18 3. compliance with the requirement is precluded or limited because of the lot's location in a
19 Federal, State, or City historic district.

20 **3604.1.1 "Disproportionately expensive" defined.** For purposes of this section,
21 "disproportionately expensive" means that the cost of grading the terrain to meet the requirement
22 exceeds 5% of the fair market value of the unimproved property.

23 **Section 3605 Relationship to Other Laws**

24 **3605.1 Federal and state laws.** Federal and state laws also govern multiple-family dwellings and
25 public accommodations. Newly constructed multiple-family dwellings may also be subject to the
26 federal Americans with Disabilities Act and the federal Fair Housing Act and their respective
27 guidelines.

28 **3605.2 City law.** This Chapter applies to some dwellings that are not covered by federal or state
29 law, such as newly-constructed single-family dwellings.

30 **3605.3 More restrictive law controls.** To the extent that the provisions of this Chapter are not
31 identical to federal or state laws, the more restrictive law controls.

Chapter 37. “Green Building” Requirements

Section 3701 Policy; Short Title

3701.1. Policy. This Chapter is intended to protect the public health and welfare by requiring an integrated approach to planning, design, construction, and operation of a covered building and its surrounding landscape, helping to mitigate the energy and environmental impacts of the building so that it is energy efficient, sustainable, secure, safe, cost-effective, accessible, functional, and productive.

3701.2. Short title. This Chapter may be cited as the Baltimore City Green Buildings Law.

Section 3702 Definitions

3702.1 General. In this Chapter, the following terms have the meanings indicated.

3702.1.1 City building. “City building” means any covered building that is owned by the Mayor and City Council of Baltimore.

3702.1.2 City-subsidized building. “City-subsidized building” means any covered building for which the City or any of its agents or contractors provides funds, resources, or financial assistance, including:

1. the sale or transfer of land substantially below its appraised value;
2. payment in lieu of taxes;
3. tax increment financing;
4. grants or loans that equal or exceed 15% of total projected project costs; or
5. installation or repair of physical infrastructure directly related to the project and with value equal to or exceeding 5% of total projected project costs.

3702.1.3 Covered building. “Covered building” means a newly constructed or extensively modified non-residential or multi-family residential building that has or will have at least 10,000 square feet of gross floor area.

3702.1.4 Extensively modified. “Extensively modified” refers to a structural modification that alters more than 50% of a building’s gross floor area, as indicated on the application for a building permit.

3702.1.4.1 Exclusions. “Extensively modified” does not include any modification that is limited to 1 or more of the following building systems:

1. mechanical,
2. electrical,
3. plumbing,
4. heating, ventilation, and air conditioning, and
5. fire protection.

1 **3702.1.5 Green Building Council.** “Green Building Council” means the U.S. Green Building
2 Council, an organization that has developed and published the LEED rating system to measure
3 the energy and environmental performance of a building.

4 **3702.1.6 LEED.** “LEED” means the Leadership in Energy and Environmental Design rating
5 system developed by the Green Building Council.

6 **3702.1.7 LEED rating system.** “LEED rating system” means the particular LEED rating
7 system that applies to a covered building, as specified in the regulations adopted under this
8 Chapter.

9 **3702.1.8 Multi-family residential building.** “Multi-family residential building” means:

- 10 1. any multi-family residential building that contains 5 or more dwelling units and is taller
11 than 3 stories; or
- 12 2. any mixed-use building that contains a residential component and is taller than 3 stories.

13 **3702.1.9 Newly constructed.** “Newly constructed” refers to a new, stand-alone building or an
14 addition to an existing building.

15 **3702.1.9.1 Exclusions.** “Newly constructed” does not include any change to an existing
16 portion of a building.

17 **3702.1.10 Non-residential building.** “Non-residential building” means a building not used
18 as a dwelling.

19 Section 3703 Regulations

20 **3703.1 In general.** The Building Official must issue regulations to administer this Chapter.

21 **3703.2 Required elements.** Those regulations must specify:

- 22 1. the LEED rating system, and any equivalent energy and environmental design standard, that
23 applies to each type of covered building under § 3705 {“STANDARDS AND REQUIREMENTS”},
- 24 2. the process by which to verify compliance with any applicable standard, including the types
25 of persons who are qualified to verify compliance,
- 26 3. standards and procedures under which the waivers may be requested under § 3708
27 {“WAIVERS”}, and
- 28 4. standards and procedures for any enforcement mechanism, such as performance bonds, that
29 the Building Official finds necessary to accomplish the purposes of this Chapter.

30 Section 3704 *{Reserved}*

31 Section 3705 Standards and Requirements

16 must achieve:

- 12 1. increase the building's land coverage by 100% or more, or
- 13 2. increase the building's gross floor area by at least 10,000 sq. ft.

14 **Section 3706 Building Permits; Occupancy Permits; Certificates of Completion**

15 **3706.1 Application for building permit.** In addition to all other submissions required by this
16 article, the applicant for a building permit for a covered building must submit to the Building

- 18 1. design plans for the building that are likely to achieve the applicable standard required
19 by § 3705 {"STANDARDS AND REQUIREMENTS"}, and
- 20 2. any other document or information the Building Official finds necessary to decide whether
21 the building will achieve the applicable standard required by § 3705.

22 **3706.2 Compliance as condition of building permit.** The Building Official must require
23 compliance with § 3705 as a condition of any building permit issued for a covered building.

24 **3706.3 Occupancy permits; Certificates of completion.** The Building Official may not issue a
25 final occupancy permit or certificate of completion for a covered building unless the Building
26 Official finds that the building has achieved the applicable standard required by § 3705.

27 **Section 3707 {Reserved}**

28 **Section 3708 Waivers**

29 **3708.1 When authorized.** The Building Official may approve full or partial waivers of the
30 requirements of this Chapter to the extent that:

- 31 1. compliance would be impractical or unduly burdensome, and
- 32 2. the public interest would be served by the waiver.

33 **3708.2 Conditions, etc.** The Building Official may impose any conditions, restrictions, or
34 limitations on a waiver that the Building Official considers necessary or appropriate in the
35 circumstances.

18 this Chapter.

19 **3803.2 Contents.** These rules and regulations:

- 20 1. must include:
 - 21 a. procedures for determining the number of trips to be attributable to projects in a
22 particular Traffic-Mitigation Zone or Subzone,
 - 23 b. procedures for determining what constitute extraordinary circumstances requiring
24 that an impact area of up to a 1 mile radius be considered for purposes of § 3802.2
25 {"OUTSIDE TRAFFIC-MITIGATION ZONE"},
 - 26 c. a schedule of the fees that an applicant may be charged under [§ 3804] § 3804.3
27 {"EXPENSES"}, and,
 - 28 d. an accounting method, adopted in accordance with § 3807.5.3 {"ACCOUNTING
29 METHOD TO BE PUBLISHED"}, to identify what specific projects individual fees are
30 obligated to for purposes of a review under § 3807.5.1 {"REVIEW OF FEE USE"},
- 31 2. may establish:
 - 32 a. usage categories for determining the number of trips generated by differing uses
33 within Traffic-Mitigation Zones, and
 - 34 b. procedures for designating, within Traffic-Mitigation Zones, Subzones with differing
35 trip-generation formulas, and
- 36 3. may include any other procedures, standards, or requirements consistent with this Chapter.

1 **3803.3 Public review.** All proposed rules and regulations under this Chapter must be published for
2 public comment on the Department of Transportation’s website by the Director for at least 45 days.
3 During the 45-day public comment period the Director must hold 1 or more public hearings on the

5 publication and hearing, the Director may modify and adopt rules and regulations by filing a copy of

- 8 1. the Building Official,

- 12 5. the Director of Planning.

13 **Section 3804 Traffic-Impact Study**

14 **3804.1 Scope of section.** This § 3804 is applicable to all proposed projects located outside of a
15 Traffic-Mitigation Zone.

16 **3804.2 How conducted.**

17 **3804.2.1 By DoT or consultant.** The Department of Transportation may itself undertake the
18 study or contract with independent consultants for the study, as the Director considers necessary
19 or appropriate.

20 **3804.2.1.1 Consultant conflicts.** For a consultant to be eligible to undertake a Traffic-
21 Impact Study, the consultant must certify to the Director, in the manner prescribed by the
22 Director, that the consultant is free of any conflicts of interest.

23 **3804.2.1.2 Conflict defined.** For purposes of this § 3804.2, a “conflict of interest” is
24 defined as any consultant having materially participated in the development of the
25 application or having worked for the applicant on any application within the prior 24 months.

26 **3804.2.2 Scope of study.** The area and scope of each study is to be determined by the
27 Department of Transportation, in accordance with the rules and regulations adopted under § 3803
28 {“DoT rules and regulations”}.

29 **3804.2.2.1 Minimum area of study.** The area of a study required under this § 3804 must
30 not be smaller than the impact area of the project, as determined using the method described
31 in § 3802.2.1 {“DETERMINATION OF IMPACT AREA”}.

32 **3804.3 Expenses.** All reasonable expenses incurred in undertaking or contracting for the study must
33 be paid by the applicant, and will be imposed and collected as provided in [§ 108] § 118 {“LIABILITY
34 FOR EXPENSES...”} of this Code for fees and service charges.

35 **3804.3.1 Initial payment.** Before the study begins, the applicant must pay the expenses
36 estimated under § 3802.4 {“DOT INITIAL DETERMINATION”}.

1 **3804.3.2 Balance.** After the study is completed, but before any permit may be issued, the
2 applicant must pay any difference between the initial amount paid under § 3804.3.1 and the
3 actual expenses incurred for the study.

4 **3804.3.2.1 Refund.** After the study is completed, subject to appropriation by the Board of
5 Estimates, the applicant is entitled to a refund of any payments made under § 3804.3.1 that
6 exceed the actual expenses incurred for the study plus a reasonable service charge.

7 **3804.4 Applicant's option on delay.** If the Traffic-Impact Study is not completed within 60
8 business days after the initial payment is made under § 3804.3.1:

- 9 1. the applicant may proceed to contract for the Traffic-Impact Study with a consultant selected
10 from a list of consultants prequalified by the Department of Public Works' Office of Boards
11 and Commissions; and
- 12 2. subject to appropriation by the Board of Estimates, the applicant is entitled to a full refund of
13 all fees paid to the City for the uncompleted Traffic-Impact Study.

14 **3804.5 Mitigation.** The applicant and the Department of Transportation must negotiate in good
15 faith to determine who must pay for and undertake the actions necessary or appropriate to mitigate
16 the adverse traffic impacts identified in the Traffic-Impact Study. If no agreement is reached, the
17 application is not approved.

18 Section 3805 Traffic-Mitigation Zones

19 **3805.1 Purpose of Zones.** Areas designated as Traffic-Mitigation Zones are areas that have
20 overburdened and interrelated transportation networks and that are anticipated to experience
21 significant development. Heightened review of development that might impact the transportation
22 networks in these areas is therefore necessary.

23 **3805.2 Traffic-Management Plans for Zones.** The Planning Commission may adopt a 10-year
24 traffic-management plan for each Traffic-Mitigation Zone and review and update each plan every 5
25 years.

26 **3805.2.1 Required plan inclusions.** Each plan must, among other things:

- 27 1. project the number of trips that reasonably might be expected to be generated in the
28 Zone, based on new development (including redevelopment of vacant and underutilized
29 parcels),
- 30 2. identify multimodal transportation solutions to mitigate the likely growth in traffic
31 congestion, and
- 32 3. based on the Director's recommendations, indicate what projects may be funded, in
33 whole or in part, by Traffic-Mitigation Fees from the Zone.

34 **3805.2.2 Plan exclusions.** The plan may not include Traffic-Mitigation Fee funding for system
35 preservation projects such as street resurfacing, reconstruction, or other projects not required to
36 mitigate the growth in traffic congestion unless the system preservation projects are reasonably
37 necessary to improve safety or capacity.

38 **3805.3 Designated Zones.** There are 5 Traffic-Mitigation Zones in the City of Baltimore.

3 thence running with the centerline of said North Calvert Street to the place of beginning.

5 **3805.3.5 Southwest Zone.** The area within the following boundaries is the “Southwest Traffic-
6 Mitigation Zone”:

8 BEGINNING for the same at the point formed by the intersection of the centerline of West Mulberry
9 (aka US Route 40) and the centerline of North Martin Luther King, Jr. Boulevard, varying in width;
10 thence running with the centerline of said North Martin Luther King, Jr. Boulevard, with meridian
11 reference to the Baltimore City Survey Control System, the following courses:

- 12 (1) Southerly and Southeasterly, passing over West Baltimore Street whereas said North Martin

15 King, Jr. Boulevard and the centerline of Russell Street (Baltimore-Washington Parkway, MD

9 Section 3806 Traffic-Mitigation Fee

10 **3806.1 Scope of section.** This § 3806 is applicable to all proposed projects located inside of a
11 Traffic-Mitigation Zone.

12 **3806.2 General.** A Traffic-Mitigation Fee is a payment that, by authority of Charter Article II,
13 §§ (40) and (47), must be paid for projects that meet the criteria established in § 3802.3 {“WITHIN
14 TRAFFIC-MITIGATION ZONE”}.

15 **3806.2.1 Application and processing fee.** An application to begin the required
16 Traffic-Mitigation Fee process must be:

- 17 1. made in the form and within the time frame set forth in the rules and regulations adopted
18 under this Chapter; and
- 19 2. accompanied by a processing fee in the amount set by these rules and regulations.

20 3806.3 Assessment of fee.

21 **3806.3.1 Trip formula.** The rules and regulations adopted under this Chapter must establish:

- 22 1. procedures for determining the number of trips attributable to various types of projects in
23 a particular Traffic-Mitigation Zone or Subzone; and
- 24 2. adjustment factors for calculating the number of non-single-occupant-vehicle trips
25 attributable to various types of projects.

26 **3806.3.2 Fee Rates.** The fee rate per trip is as set by the Board of Estimates, in consultation
27 with the Director, for each Zone.

28 **3806.3.2.1 Temporary limitation on Fee Rate increases.** For the period beginning when a
29 fee rate is initially set for a Zone, and ending on December 31, 2016, the Board of Estimates
30 may not increase the fee rate for that Zone more often than once every 5 years.

31 **3806.3.3 Fee formula.** The amount of the Traffic-Mitigation Fee assessed on a specific project
32 is determined by multiplying:

- 33 1. the applicable rate per trip, as of the date that the permit is applied for, for the Zone
34 where the project is located, by
- 35 2. the number of trips that the Department of Transportation attributes to the project using
36 the procedure established under § 3806.3.1.

1 **3806.4 Trip-Generation Credits.**

2 **3806.4.1 General.** The Director must issue trip-generation credits to any proposed project that
3 meets the requirements of this § 3806.4. Each credit issued reduces by 1 the number of trips
4 used to calculate the amount of the Traffic-Mitigation Fee under § 3806.3.

5 **3806.4.2 Authorized credits.** Trip-generation credits are authorized as follows.

6 **3806.4.2.1 Negotiated agreement.** The Director may agree to issue trip-generation credits
7 for a proposed project if:

- 8 1. the Mayor and City Council enter into a binding, written mitigation agreement with
9 the developer of the project that requires the performance of specific actions that the
10 Director determines will reduce the number of trips actually generated by the project,
- 11 2. the mitigation agreement requires the developer to require all subsequent purchasers
12 or occupants of the property to abide by the ongoing requirements of the mitigation
13 agreement,
- 14 3. the mitigation agreement includes a mechanism making it binding on all future
15 successors and assigns who may acquire any interest in the property in the future,
- 16 4. the mitigation agreement requires the Director to issue a number of credits
17 equivalent to the number of trips that the director calculates will be avoided through
18 the actions agreed to by the developer, and
- 19 5. the mitigation agreement, together with any adjustment factors calculated using the
20 procedure established under § 3806.3.1(2), does not reduce the total number of trips
21 that would otherwise be used to calculate the Traffic-Mitigation Fee by more than
22 50%.

23 **3806.4.2.2 Change in occupancy within 1 year.** For the change in occupancy of a
24 structure that has been vacant for less than 1 year before the date of application for a permit,
25 the Director must issue trip-generation credits equivalent to the number of trips attributable
26 to the previous use, as calculated using the procedure established under § 3806.3.1 {"TRIP
27 FORMULA"}.

28 **3806.4.3 Buy-out of credits.** An owner or occupier of property that has benefitted from the
29 issuance of trip-generation credits may not change the use of the property in any way that would
30 no longer qualify the property for 1 or more trip-generation credits previously issued unless the
31 owner or occupier first cancels the previously issued credits.

32 **3806.4.3.1 Formula.** To cancel those credits, the owner or occupier must pay to the
33 Director of Finance an amount equal to the greater of:

- 34 1. the number of trip-generation credits being canceled, multiplied by the Traffic-
35 Mitigation Fee rate that was in force for the Zone when the credits were issued, or
- 36 2. the number of trip-generation credits being canceled, multiplied by the Traffic-
37 Mitigation Fee rate that is in force in the Zone when the credits are cancelled.

38 **3806.4.4 Obligation created by acceptance of credits.** The acceptance of trip-generation
39 credits under this § 3806.4 creates a binding obligation on the persons accepting the credits to
40 fulfill the representations and agreements that allowed the credits to be issued. In addition to any

1 other remedy or enforcement action, the Director may enforce these obligations by seeking both
2 legal and equitable remedies.

3 **3806.5 Right-of-way dedication set-off.** If an applicant controls property that the Director
4 determines to be necessary for the construction of a traffic-mitigation project, the Director may
5 accept the dedication of the needed property to the City's use and issue a set-off credit toward the
6 Traffic-Mitigation Fee assessed on a project in exchange. The total amount of the Traffic-Mitigation
7 Fee to be paid would then be reduced by the appraised value of the property dedicated to City use.

8 **3806.6 Payment of Fees.**

9 **3806.6.1 \$50,000 or less.** If the Traffic-Mitigation Fee assessed for a proposed project is
10 \$50,000 or less, the Fee must be paid to the Director of Finance in full before any permits for the
11 work are issued.

12 **3806.6.2 More than \$50,000.** If the Traffic-Mitigation Fee assessed for a proposed project is
13 more than \$50,000, the Director of Transportation may negotiate installment payments to be
14 made over a period of up to 5 years from the issuance of a building permit for all amounts in
15 excess of \$50,000. The initial payment of at least \$50,000 must be paid to the Director of
16 Finance in full before any permits for the work are issued. Any installment plan under this
17 § 3806.6.2 requires the approval of the Board of Estimates to become effective.

18 **3806.6.2.1 Interest to be charged on installment payments.** If a Traffic-Mitigation Fee is
19 to be paid in installments under an agreement authorized by § 3806.6.2, installment payments
20 must include an additional interest charge at the current City borrowing rate as determined
21 by the Director of Finance.

22 **Section 3807 Use of Fees**

23 **3807.1 Separate revenue accounts.** Traffic-Mitigation Fees collected under this Chapter are to be
24 deposited to the General Fund and accounted for in separate revenue accounts designated to indicate
25 precisely how much revenue is derived from each Traffic-Mitigation Zone.

26 **3807.2 Fees to benefit Zone of origin.** Subject to appropriation, revenue derived from
27 Traffic-Mitigation Fees in each Traffic-Mitigation Zone must be used only for the purposes
28 described in § 3807.3 or for:

- 29 1. designing and constructing projects to benefit the transportation infrastructure of the Zone
30 from which the fees derive, as approved by the Planning Commission in the Traffic-
31 Management Plan adopted under § 3805.2 {"TRAFFIC-MANAGEMENT PLANS"}.
- 32 2. designing and constructing projects to benefit the transportation infrastructure of the Zone
33 from which the fees derive, as certified by the Director, if the Planning Commission has not
34 adopted a Traffic-Management Plan under § 3805.2, or
- 35 3. defraying the planning and administrative costs, of no more than 10% of all revenue
36 collected, of implementing this Chapter.

37 **3807.3 Fees may defray cost of site access improvements.**

38 **3807.3.1 Site access improvements.** Subject to the approval of the Board of Estimates, the
39 Director may permit up to 33% of the Traffic Mitigation Fee, after deduction of credits, paid by
40 an applicant to be used for minor site access improvements, including turning lanes,
41 acceleration/deceleration lanes, traffic signals, or similar improvements.

D102 General requirements. New buildings and structures, and additions to existing buildings and structures, within the Downtown Fire District must be constructed:

1. within the height and area limitations of Table 503 {“ALLOWABLE BUILDING HEIGHTS AND AREAS”} of this Code, and
2. of 1 of the following types of construction, as defined in Chapter 6 {“TYPES OF CONSTRUCTION”} and regulated in Tables 601 {“FIRE-RESISTANT RATINGS FOR BUILDING ELEMENTS”} and 602 {“FIRE-RESISTANT RATINGS FOR EXTERIOR WALL”} of this Code:
 - a. fireproof (Type I),
 - b. protected noncombustible (Types IIA and IIB),
 - c. ordinary protected (Type IIIA), or
 - d. heavy timber (Type IV).

D103 Types IIIB, VA, and VB construction not permitted. New buildings and structures, and additions to existing buildings and structures, within the Downtown Fire District may not be of Type IIIB, VA, or VB construction, as defined in Chapter 6 {“TYPES OF CONSTRUCTION”} of this Code.

§ 7-101. City adoption.

(a) *In general.*

The International Property Maintenance Code [(2009 Edition)] (2012 EDITION) is adopted as part of the Building, Fire, and Related Codes of Baltimore City, subject to the additions, deletions, amendments, and other modifications contained in this Part VII.

(b) *Codification.*

Unless otherwise specified, chapter and section numbers in this Part VII refer to the chapter and section numbers of the International Property Maintenance Code.

§ 7-102. City modifications.

The additions, deletions, amendments, and other modifications adopted by the City are as follows:

Chapter 1. SCOPE AND Administration

Section 101 General

101.1 Title. [These] THE regulations CONTAINED IN THIS CODE constitute and are known as the “BALTIMORE CITY Property Maintenance Code [of Baltimore City]”.

101.1.1 References to “this Code”. All references to “this Code” refer to the BALTIMORE CITY Property Maintenance Code [of Baltimore City].

102.2.3 Owner and operator responsible. Except as otherwise specified, each owner and each operator of a structure or premises is responsible for the maintenance of that structure or premises.

22 **202.2.8 Occupancy.** “Occupancy” has the meaning stated in § 202.2 of the Baltimore City
23 Building Code.

24 **202.2.9 Occupant.** “Occupant” has the meaning stated in § 202.2 of the Baltimore City
25 Building Code.

26 **202.2.10 Operator.** “Operator” has the meaning stated in § 202.2 of the Baltimore City
27 Building Code.

28 **202.2.11 Owner.** “Owner” means any person that:

- 29 1. has a legal or equitable interest in the property,
- 30 2. is recorded in the land records as holding title to the property, or
- 31 3. otherwise has control of the property, with or without accompanying possession of the
32 property, including:
 - 33 a. a guardian of the person or estate of an owner,

- b. a trustee, including a trustee in bankruptcy, of an owner, or
- c. the personal representative of the estate of an owner.

202.2.12 Person. “Person” has the meaning stated in § 202.2 of the Baltimore City Building Code.

202.2.13 Premises. “Premises” means a lot or group of lots, together with all or any part of any structures on the lot or group of lots, considered as a unit devoted to a particular use, including accessory structures and open spaces required or used in connection with that particular use.

202.2.14 Rooming house. “Rooming house” means a building that:

1. is not a multiple family dwelling, and
2. contains more than 2 rooming units occupied or designed or intended to be occupied by individuals who, even though they might share common areas and facilities, do not form a single housekeeping unit and do not provide compensation under a single lease for occupancy of the rooming house.

202.2.14.1 Inclusions. “Rooming house” includes a hotel, motel, or boarding house.

202.2.15 Rooming unit. “Rooming unit” means any room or group of rooms that form a single habitable unit occupied or designed or intended to be occupied for sleeping or living, but not for cooking purposes.

202.2.16 Strict liability offense. “Strict liability offense” means an offense in which the prosecution in a legal proceeding is not required to prove knowledge or intent as a part of its case. It is enough to prove that the defendant either did an act that was prohibited or failed to do an act that the defendant was legally required to do.

202.2.17 Structure. “Structure” has the meaning stated in IPMC § 202 and, unless the context indicates otherwise, includes premises and lands.

202.2.18 Trash. “Trash” means rubbish, as defined in IPMC § 202.

202.2.19 Workmanlike. “Workmanlike” means executed in a skilled manner in accordance with the standards of the trade – e.g., generally plumb, level, square, in line, undamaged, and without marring adjacent work.

Chapter 3. General Requirements

Section 301 General

301.1 Scope. This Chapter governs the minimum requirements and the responsibilities of persons for repair and maintenance of structures, equipment, and premises.

301.2 Responsibility.

301.2.1 Owners and operators. Except as otherwise specifically provided, the owner and the operator of any premises are responsible for maintaining all structures and exterior property areas in compliance with all requirements of this Chapter.

301.2.2 Occupants – In general. The occupant of any premises:

- 1 1. must give the owner and the owner’s agents access to the premises, at all reasonable
2 times, for the purpose of inspecting and making repairs or alterations as necessary to
3 effect compliance with this Code or with any lawful rule or regulation adopted or order
4 issued under this Code,
- 5 2. may not obstruct any required means of egress,
- 6 3. may not store flammable liquids or gas or unsafe quantities of combustible materials,
- 7 4. if in control of the heating facilities, must maintain a sufficiently high temperature in
8 all parts of the unit to prevent damage to the plumbing system, and
- 9 5. is responsible for:
 - 10 a. keeping in a clean and sanitary condition the occupant’s unit and any other part
11 of the premises that the occupant occupies or controls, and
 - 12 b. otherwise complying with the requirements specified in § 308 {“OCCUPANT’S
13 SANITARY RESPONSIBILITY”} of this Chapter.

14 **301.2.3 Occupants – Vandalism.** The occupant of a non-owner occupied dwelling may not
15 destroy, deface, damage, impair, or carry away, nor permit any other person on the premises
16 to destroy, deface, damage, impair, or carry away any of the facilities, equipment, appurtenances,
17 or any part of the structure of the dwelling.

18 **301.3 Vacant structures and land.** All vacant structures and their premises and all vacant land
19 must be maintained in a clean, sanitary, and safe condition, as provided in this Code.

20 **301.4 Lead-based paint.** Lead-paint hazards must be abated in accordance with:

- 21 1. the rules and regulations of:
 - 22 a. the Maryland Department of the Environment; and
 - 23 b. the Baltimore City Health Department; and
- 24 2. the Department of Public Works’ requirements governing discharges into the storm water
25 system.

26 **301.4.1 Unoccupied dwelling unit – Scope.** These provisions apply to any dwelling unit that:

- 27 1. is the subject of a notice or order for the treatment of lead paint, and
- 28 2. becomes unoccupied either:
 - 29 a. before the notice or order is served, or
 - 30 b. while the notice or order is still outstanding.

31 **301.4.2 Unoccupied dwelling unit – Posting property.** If a dwelling unit is or becomes
32 unoccupied, the Health Commissioner immediately must post 1 or more public notices in, on, or
33 around the dwelling unit stating that the dwelling unit may not be reoccupied until the lead paint
34 notice or order has been abated.

1 **301.4.3 Unoccupied dwelling unit – Reoccupancy prohibited.** If a dwelling unit is or
2 becomes unoccupied, the dwelling unit may not be reoccupied until:

- 3 1. the lead paint notice or order has been abated, and
- 4 2. the Health Commissioner has given written approval of reoccupancy.

5 **301.4.4 Unoccupied dwelling unit – Removing notice, etc., prohibited.** Until the Health
6 Commissioner has give written approval of reoccupancy, no person may remove, deface, or
7 otherwise tamper with any notice that has been posted under this section.

8 **301.4.5 Unoccupied dwelling unit – Unauthorized reoccupancy.** If a dwelling unit
9 is reoccupied in violation of this section:

- 10 1. each day that an unauthorized occupancy continues is a separate offense, and
- 11 2. the owner, operator, and unauthorized occupant of the unit are subject to the following
12 penalties:
 - 13 a. in a criminal prosecution, a criminal fine of up to \$500 for each offense, and
 - 14 b. in an action seeking equitable relief, a civil fine of up to \$500 for each offense.

15 **Section 302 Exterior Property Areas** *{Not Adopted}*

16 **Section 303 Swimming Pools, Spas, and Hot Tubs** *{Not Adopted}*

17 **Section 304 Repair and Maintenance of Structures**

18 **304.1 General.** The interior and exterior of a structure must be maintained in good repair and
19 in a structurally sound and sanitary condition.

20 **304.1.1 Unsafe conditions.** *{Not Adopted}*

21 **304.2 Protective treatment.** *{As in IPMC}*

22 **304.3 Premises identification.** Buildings must display identifying address numbers as required by
23 City Code Article 26, Subtitle 6 {"Building Address Numbers"}

24 **304.4 Structural members.** All interior and exterior structural members must be:

- 25 1. maintained in a structurally sound condition and free from deterioration, and
- 26 2. capable of safely supporting the imposed dead and live loads.

27 **304.5 Foundation walls.** *{As in IPMC}*

28 **304.6 Exterior walls.** *{As in IPMC}*

29 **304.7 Roofs and drainage.** The roof and flashing must be sound, tight, and without defects that
30 admit rain. Roof drainage must be adequate to prevent dampness or deterioration in the walls or
31 interior portion of the structure. Roof drains, gutters, and downspouts must be provided and
32 maintained in good repair and free from obstructions. Roof water must be discharged away from the
33 foundation and may not be discharged in a manner that creates a public nuisance.

- 1 **304.8 Decorative features.** *{As in IPMC}*
- 2 **304.9 Overhang extensions.** *{As in IPMC}*
- 3 **304.10 Stairways, floors, decks, etc.** Every interior and exterior stairway, floor, deck, porch, and
4 balcony, and all their appurtenances must be:
5
- 6 1. structurally sound,
- 7 2. properly anchored and capable of supporting the imposed loads, and
8
- 9 3. maintained in good repair and safe condition.
- 10 **304.11 Chimneys and towers.** *{As in IPMC}*
- 11 **304.12 Handrails and guards.** *{As in IPMC}*
- 12 **304.13 Window, skylight, and door frames.** *{As in IPMC}*
- 13 **304.14 Insect screens.** *{Not Adopted}*
- 14 **304.15 Doors.**
- 15 **304.15.1 General.**
- 16 1. All doors, door assemblies, and hardware must be maintained in good condition.
- 17 2. Except as otherwise required for means of egress doors, locks and latching hardware
18 must be provided at all entrances to dwelling units and rooming units and must tightly
19 secure the doors at those entrances.
- 20 3. Doors must fit properly within their frames.
- 21 4. Except for a building where the entrances are staffed by security personnel or where
22 unobstructed access is provided to the entrance of each unit, in a building that contains
23 2 or more dwelling units, an electric doorbell must be provided for each dwelling unit in
24 that building.
- 25 **304.15.2 Interior.** Every interior door must be capable of being opened and closed by being
26 securely attached and properly equipped with properly functioning attachment and latching
27 hardware.
- 28 **304.16 Basement hatchways.** *{As in IPMC}*
- 29 **304.17 Guards for basement windows.** *{As in IPMC}*
- 30 **304.18 Building security.** *{As in IPMC}*
- 31 **304.19 Gates.** *{As in IPMC}*
- 32 **304.20 Interior surfaces.** All interior surfaces, including floors, walls, ceilings, windows, and
33 doors, must be maintained in good, clean, and sanitary condition. Peeling, chipping, flaking, or
34 abraded paint must be repaired, removed, or covered. Cracked or loose plaster, decayed wood, and
35 other defective surface conditions must be corrected. Floors in kitchens, bathrooms, lavatories, toilet
36 rooms, and laundry rooms must be kept impervious to water.

- 1 **304.21 Grading and drainage.** All premises must be graded and maintained to:
- 2 1. drain away from the foundation of any structure and away from adjoining property,
- 3 2. prevent the erosion of soil, and
- 4 3. prevent the accumulation of stagnant water.
- 5 **304.22 Sidewalks, driveways, etc.** All sidewalks, walkways, stairs, driveways, parking spaces, and
6 similar areas must be kept in good repair and free from hazardous conditions.
- 7 **304.23 Exhaust vents.** Pipes, ducts, conductors, fans, or blowers may not be allowed to discharge
8 gases, steam, vapor, hot air, grease, smoke, odors, or other gaseous or particulate wastes directly on
9 any abutting or adjacent public or private property or on any property areas occupied by another in
10 the same building.
- 11 **304.24 Accessory structures.** All accessory structures, including detached garages, fences, gates,
12 walls, and swimming pools, must be maintained in a structurally sound condition and in good repair.
- 13 **304.25 Defaced property.** If an exterior surface of a structure has been defaced by carvings,
14 markings, or graffiti, the surface must be restored to an approved state of maintenance and repair.
- 15 **304.26 Nuisance or hazardous conditions.** All premises must be kept free of any object, material,
16 or condition that constitutes a nuisance or a fire, accident, or health hazard.
- 17 **304.27 {Reserved}**
- 18 **304.28 Ratproofing.** All buildings must be ratproofed and maintained in a ratproof condition by the
19 owner or his agent. Ratproofing methods include:
- 20 1. preventing entrance by blocking passages with rat-resistant material, and
- 21 2. paving basements and any other areas that are in contact with the soil.
- 22 **304.29 Equipment.** All equipment required by the Building, Fire, and Related Codes of Baltimore
23 City must be maintained in good working condition.
- 24 **304.30 Fire protection.** All required fire protection, including separation between nonresidential
25 and residential occupancies, must be maintained in good repair. All fire doors must be equipped and
26 maintained as required by the Fire Code of Baltimore City.
- 27 **Section 305 Exterior Sanitary Maintenance – General**
- 28 **305.1 General.** All lots and exterior premises, including abutting sidewalks, gutters, and alleys,
29 must be maintained in a clean, safe, and sanitary condition.
- 30 **305.2 Grass and weeds.**
- 31 **305.2.1 “Weeds” defined.** In this section, “weeds” includes all plants and vegetation other
32 than:
- 33 1. trees or shrubs, or
- 34 2. cultivated flowers and gardens.

1 **305.2.2 Maintenance requirements.** All premises and exterior property must be maintained
2 free of grass, weeds, or plant growth in excess of 8 inches (203 mm). All noxious weeds are
3 prohibited.

4 **305.3 Trees and shrubbery.** All trees and shrubbery that are dangerous to life and property or that
5 create a fire or traffic hazard must be pruned or removed to eliminate the danger or hazard.

6 **305.4 Pest control.** All exterior property areas must be kept free from infestation by insects,
7 rodents, and other pests, from rodent harborage, and from the conditions that attract pests. Where
8 pests are found, they must be promptly exterminated by approved processes that will not be injurious
9 to human health.

10 **305.5 Motor vehicles and trailers.** Except only as otherwise expressly authorized by law, the
11 following rules apply to all motor vehicles and trailers.

12 1. No motor vehicle or trailer may be parked, kept, or stored, whether or not covered, on any
13 exterior premises if:

14 a. it is inoperative, unregistered, or fails to display current registration tags, or

15 b. it is in a state of disassembly or disrepair or in the process of being stripped or
16 dismantled.

17 2. A motor vehicle or trailer may be parked, kept, or stored only on a dustless all-weather
18 surface constructed and maintained in accordance with the Building Code and Zoning Code
19 of Baltimore City.

20 3. Painting a motor vehicle or trailer is prohibited unless conducted inside an approved spray
21 booth.

22 **Exception:** On premises with a proper use permit, a vehicle may undergo overhaul, including
23 body work, if that work is performed inside a structure or similarly enclosed area designed and
24 approved for that purpose.

25 **305.5.1 Registered owner responsible.** For a motor vehicle or trailer parked, kept, or stored in
26 violation of § 305.5(1) or (2), the registered owner of the motor vehicle or trailer is responsible
27 for the violation, jointly and severally with the property owner.

28 **305.6 Swimming pools.** Swimming pools must be maintained in a clean, safe, and sanitary
29 condition.

30 **305.7 Outdoor storage.** Outdoor storage must be neat and orderly. All stored objects and materials
31 must be elevated at least 1 foot off the ground to prevent rat harborage, unless elevation is
32 determined unnecessary by the commissioner.

33 **305.7.1 Caveat.** Nothing in this section authorizes any outdoor storage that is otherwise
34 prohibited by law.

35 **305.8 Snow and ice on sidewalks.** After any snowfall that results in an accumulation of snow or
36 ice on the ground, the snow and ice must be removed and cleared away from all sidewalks that abut
37 the premises.

38 **305.8.1 Time for compliance.** The snow and ice must be removed and cleared away:

39 1. within 3 hours after the snow has stopped falling; or

2. if the snow stopped falling between 3 p.m. and 6 a.m., before 11 a.m.

305.8.1 Manner of compliance. The snow and ice must be removed and cleared away in a manner that:

1. leaves a clear path that is at least 2 feet wide; and
2. does not obstruct the passage of water in the gutters.

Section 306 Exterior Sanitary Maintenance – Trash, Garbage, and Debris

306.1 Accumulation prohibited. All premises, including abutting sidewalks, gutters, and alleys, as well as the interior of every structure, must be kept free of any accumulation of trash, garbage, and debris, including any animal waste, construction material, equipment, furniture, appliances, and similar objects and materials.

306.2 Bulk trash. If discarded or abandoned articles are too large to be disposed of in required receptacles, they must be conveyed to an appropriate landfill or other approved disposal site.

306.3 No deposit on sidewalks, etc. No trash, garbage, or debris may be deposited on any sidewalk, alley, or street or on any public or private lot, except as specified in §§ 306.4 through 306.7 of this Chapter.

306.4 Storage receptacles – Required. Trash, garbage, or debris may not be stored or placed out for collection except in approved storage receptacles. The owner or operator of every occupied premises must [arrange for] PROVIDE a sufficient number of these storage receptacles to receive and store trash, garbage, and debris from individual units between days of collection. The receptacles must be maintained in a location accessible to occupants.

306.5 Storage receptacles – Location. If, in the opinion of the Code Official, the exterior maintenance of storage receptacles is causing nuisance or blight, the Code Official may require that, between days of collection, the receptacles be stored:

1. inside the building they serve, or
2. in the discretion of the Code Official, within a contiguous structure.

306.6 Storage receptacles – Specifications and maintenance.

306.6.1 Specifications.

306.6.1.1 General. Each storage receptacle must:

1. be made of metal or some other durable material approved by the Code Official,
2. be watertight, with tight-fitting covers and handles, and
3. have a capacity of not more than 32 gallons.

306.6.1.2. Exceptions.

1. Receptacles used for recycling need not have covers.
2. Yard waste may be bagged or bundled.

1 **306.6.2. Maintenance.** Each storage receptacle must be:

- 2 1. maintained in good repair, and
- 3 2. kept tightly closed to prevent blight, nuisance, pest infestation, and dispersal of trash,
- 4 garbage, or debris.

5 **306.7 Placement for collection.** Storage receptacles:

- 6 1. should be placed out for collection no later than 6 a.m. of the day of collection,
- 7 2. may not be placed out on any sidewalk or along an alley earlier than 6 p.m. of the evening
- 8 before the day of collection, and
- 9 3. if placed on a sidewalk or along an alley, must be returned to the premises no later than 6
- 10 a.m. on the day after collection.

11 **306.8 Owner transport.** At any building for which the City does not provide collection services,
12 the owner and operator must collect and transport the building's trash, garbage, and debris to an
13 appropriate landfill or other approved disposal site.

14 **Section 307 Interior Sanitary Maintenance**

15 **307.1 General.** The interior of each unit and the shared, common, or public areas within each
16 building that contains more than one unit must be maintained in a clean and sanitary condition.

17 **307.2 Floor, furniture, etc., surfaces.** Floors, furniture, countertops, and similar surfaces must be
18 clean and free of trash, garbage, and debris, including human and animal waste and any other
19 insanitary matter or cause of nuisance.

20 **307.3 Walls, ceilings, and openings.** Walls, ceilings, windows, and doorways must be clean and
21 free of dirt, grease, soot, and any other insanitary matter or cause of nuisance.

22 **307.4 Trash, etc., receptacles.** Each unit must have a sufficient number of interior receptacles to
23 contain that unit's trash, garbage, and debris.

24 **307.5 Plumbing fixtures.** Plumbing fixtures must be kept clean and free from any foreign object or
25 material that could obstruct a fixture or a line connected to a fixture.

26 **307.6 {Reserved}**

27 **307.7 Pest control.** The interior of every building must be kept free of infestation by insects,
28 rodents, and other pests.

29 **Section 308 Occupants' sanitary responsibilities.**

30 **308.1 General.** An occupant must keep in a clean and sanitary condition the occupant's unit and
31 any other part of the premises that the occupant occupies or controls. However, the owner and
32 operator is responsible for any insanitary condition caused by a sewer back-up or a structural defect.

33 **308.2 Exteriors.** An occupant of a single-unit building and an occupant of a unit with exclusive use
34 of an exterior property area must maintain the exterior areas, including abutting sidewalks, gutters,
35 and alleys, in compliance with [§] § 305 {"EXTERIOR ... MAINTENANCE – GENERAL"} and § 306
36 {"EXTERIOR ... MAINTENANCE – TRASH, GARBAGE..."} of this Chapter. However, the owner and
37 operator are responsible for any insanitary condition caused by a sewer back-up or a structural defect.

1 **308.2.1 Exception – Residential property registration.** The owner of a property is responsible
2 for exterior sanitary maintenance under any of the circumstances described in Building Code
3 § 114.21.2b {"Liability – Failure to Register Property"}.

4 **308.2.2 Exception – Third environmental citation.** The owner of a property is responsible for
5 exterior sanitary maintenance under the circumstances described in Building Code § 114.21.2c
6 {"Liability – Third environmental citation"}.

7 **308.3 Interiors.** Except as otherwise specified in § 308.5, an occupant must maintain the interior of
8 the occupant’s unit and any other part of the building that the occupant occupies or controls in
9 compliance with § 307 {"INTERIOR ... MAINTENANCE"} of this Chapter.

10 **308.4 Pest control – Single-unit building.** An occupant of a single-unit building is responsible for
11 extermination of insects, rodents, or other pests, other than wood-destroying insects.

12 **308.5 Pest control – Multi-unit building.** An occupant of a multi-unit building is responsible for
13 extermination if the occupant’s unit is the only one affected.

14 **308.6 Trash disposal.** An occupant may dispose of trash, garbage, and debris only in compliance
15 with § 306 {"EXTERIOR ... MAINTENANCE – TRASH, GARBAGE..."} of this Chapter.

16 **308.7 Nuisances.** An occupant may not create or maintain, in or on the property that the occupant
17 occupies and controls, any condition that constitutes a nuisance.

18 SECTION 309 PEST ELIMINATION *{NOT ADOPTED}*

19 Chapter 4. Light, Ventilation, and Occupancy Limitations

20 Section 401 General

21 **401.1 Scope.** *{As in IPMC}*

22 **401.2 Responsibility.** The owner and the operator of a structure must provide and maintain light,
23 ventilation, and space conditions in compliance with these requirements.

24 **401.3 Alternative devices.** *{As in IPMC}*

25 Section 402 Light

26 **402.1 Habitable spaces.** Every habitable space must have at least 1 window facing directly to the
27 outdoors or to an open court whose facing wall is at least 3 feet (914 mm) away. The minimum total
28 glazed area for every habitable space must be 10% of the floor area of that space.

29 **Exception:** Natural light for habitable spaces may be provided through an adjoining room if:

- 30 1. the unobstructed opening to the adjoining room is at least 8% of the floor area of the
31 interior space, and
- 32 2. the glazed area providing natural light is at least 8% of the combined total floor area
33 being served.

34 **402.2 Common halls and stairways.** *{As in IPMC}*

35 **402.3 Other spaces.** *{As in IPMC}*

1 **Section 403 Ventilation** *{As in IPMC}*

2 **Section 404 Occupancy limitations**

3 **404.1 Privacy.** Dwelling units and rooming units must:

- 4 1. be arranged to provide privacy,
- 5 2. be separate from adjoining units and common areas, and
- 6 3. have a separate means of access from a hallway, landing, stairway, or street.

7 **404.2 Minimum room size.** A habitable room, other than a kitchen, may not be less than 7 feet
8 (2134 mm) in any plane dimension.

9 **404.2.1 Kitchens.** A kitchen must contain at least 35 sq. ft (3.25 sq. m.) of floor area, and,
10 if arranged as a corridor the corridor between counter fronts or between a wall and counter fronts
11 must be at least 3 feet (914 mm).

12 **404.3 Minimum ceiling heights.** Habitable spaces hallways, corridors, laundry areas, and
13 bathrooms must have a clear ceiling height of not less than 7 feet (2134 mm) over at least 50% of the
14 floor area. Toilet rooms must have a ceiling height of not less than 6½ feet (1981 mm) over at least
15 50% of the floor area

16 **Exceptions:**

- 17 1. *{Not Adopted}*
- 18 2. Basement rooms that otherwise meet the requirements of this § 404.3 may have a clear
19 height of not less than 6 feet (1829 mm) under beams, girders, ducts, and similar
20 obstructions.
- 21 3. Rooms occupied exclusively for sleeping, study, or similar purposes and having a sloped
22 ceiling over all or part of the room may have a clear ceiling height of not less than 7 feet
23 (2134 mm) over not less than 33⅓% of the required minimum floor area.
- 24 4. As allowed by regulations of the Code Official.

25 **404.3.1 Floor area calculations.** In calculating floor area for purposes of this § 404.3, only
26 those portions of the floor area with a clear height of 5 feet (1524 mm) or more may be included.

27 **404.4 Bedroom requirements.** Every bedroom must comply with the requirements of this § 404.4.

28 **404.4.1 Area for sleeping purposes.** Every bedroom occupied by 1 person must contain at least
29 70 sq. ft. (6.5 sq. m.) of floor area. Every bedroom occupied by more than one person must
30 contain at least 50 sq. ft. (4.6 sq. m.) of floor area for each occupant of the bedroom.

31
32 **404.4.2 to 404.4.5** *{As in IPMC}*

33 **404.5 Overcrowding.** Dwelling units may not be occupied by more occupants than permitted by the
34 minimum area requirements of Table 404.5.

For SI: 1 sq. ft. = 0.093 sq. m.

^a For combined living room/dining room spaces, see § 404.5.2.

^b For limitations on determining minimum occupancy area for sleeping purposes, see § 404.5.1.

404.5.1 Sleeping area. The minimum occupancy area required by Table 404.5 may not be included as a sleeping area in determining the minimum occupancy area for sleeping purposes. All sleeping areas must comply with § 404.4.

404.5.2 Combined spaces. Combined living room and dining room spaces must comply with the requirements of Table 404.5 if:

1. the total area is equal to that required for separate rooms, and
2. the space is located so as to function as a combination living room/dining room.

404.6 Efficiency unit. *{Not Adopted}*

404.7 Food preparation. A dwelling unit must contain a room or space for the storage, preparation, and cooking of food, including a sink and space and connections for a stove and refrigerator.

404.8 Closets. A dwelling unit must contain at least 1 closet, for storing clothing and other articles, with a floor area of not less than 6 sq. ft. (0.6 sq. m.). A dwelling unit with more than 1 bedroom must contain at least 1 additional closet of the same minimum size.

Exception: This section does not apply to an owner-occupied single family dwelling.

404.9 Minimum dwelling unit size. A dwelling unit must contain at least 240 sq. ft. (22.3 sq. m.) of clear floor area. At least 1 room must have not less than 120 sq. ft. (11.2 sq. m.) of floor area, with its least plane dimension not less than 8 feet (2438 mm).

Chapter 5. Plumbing Facilities and Fixture Requirements

Section 501 General

501.1 Scope. *{As in IPMC}*

5 **Section 503 Toilet Rooms and Bathrooms**

6 **503.1 Privacy.** Toilet rooms and bathrooms must provide privacy and may not constitute the only
7 means of access to a dwelling unit or to a habitable space or hall within a dwelling unit. A door with
8 interior locking device must be provided.

9 **503.2 Location.** *{As in IPMC}*

10 **503.3 Location of employee toilet facilities.** *{As in IPMC}*

11 **503.4 Floor surface.** *{Not adopted}*

12 **Section 504 Plumbing Systems and Fixtures**

13 **504.1 General.** *{As in IPMC}*

14 **504.2 Fixture clearances.** *{As in IPMC}*

15 **504.3 Plumbing system defects.** Inadequate service, inadequate venting, cross-contamination,
16 back-siphonage, improper installation, deterioration, damage, and similar defects in a plumbing
17 system must be corrected.
18

19 **Section 505 Water Systems**

20 **[505.1 General.** Every sink, lavatory, bathtub, shower, drinking fountain, water closet, or other
21 plumbing fixture must be properly connected to either a public water system or to an approved
22 private water system. All kitchen sinks, lavatories, laundry facilities, bathtubs, and showers must be
23 supplied with hot and cold running water in accordance with the National Standard Plumbing Code.]

24 **505.1 [505.2] to 505.3** *{As in IPMC}*

25 **505.4 Water heating facilities.** Every dwelling unit must have water heating facilities that are:

- 26 1. properly installed and maintained,
- 27 2. properly connected to every required sink, lavatory basin, bathtub, shower, and laundry
28 facility,
- 29 3. properly equipped with an approved combination temperature and pressure-relief valve and
30 with a relief-valve discharge pipe,
- 31 4. capable of automatically heating water to a temperature of not less than 110° F (43° C), and
- 32 5. capable of meeting normal demands at every required outlet.

33 **505.4.1 Venting gas-fired heater.** A gas-fired water heater must be vented to the outside air.

34 **Section 506 Sanitary Drainage System** *{As in IPMC}*

1 Section 507 Storm Drainage

2 **507.1 General.** Drainage of roofs and paved areas, yards and courts, and other open areas on the
3 premises may not be discharged in a manner that violates either:

- 4 1. the drainage requirements of the Baltimore City Building Code, or
- 5 2. the stormwater management requirements of the City Code.

6 Chapter 6. Mechanical and Electrical Requirements

7 Section 601 General

8 **601.1 Scope.** *{As in IPMC}*

9 **601.2 Responsibility.** The owner and the operator of a structure must provide and maintain
10 mechanical and electrical facilities and equipment in compliance with these requirements.

11 Section 602 Heating Facilities

12 **602.1 Facilities required.** *{As in IPMC}*

13 **602.2 Residential occupancies.** Dwellings must be provided with properly installed and maintained
14 heating facilities capable of maintaining a room temperature of 70° F (21° C) in all habitable rooms,
15 bathrooms, and toilet rooms. Cooking appliances may not be used to provide space heating to meet
16 the requirements of this section.

17 **602.3 Heat supply.** Every owner and operator who rents, leases, or lets one or more dwelling units,
18 rooming units, or dormitory, or guest rooms must supply sufficient heat during the period of October
19 1 through April 30, inclusive, to maintain an average temperature of:

- 20 1. not less than 70° F (21° C) in all habitable rooms, bathrooms, and toilet rooms, and
- 21 2. not less than 65° F (18° C) in any other room.

22 **Exception:** *{Not Adopted}*

23 **602.4 Occupiable work spaces.** Indoor occupiable work spaces must be supplied with sufficient
24 heat during the period of October 1 through April 30, inclusive, to maintain a temperature of not less
25 than 65° F (18° C) during the period the spaces are occupied.

26 **Exceptions:** *{As in IPMC}*

27 **602.5 Room temperature measurement.** *{As in IPMC}*

28 **602.6 Central heating units.** A central heating unit must be:

- 29 1. properly installed and maintained,
- 30 2. if fuel-burning, properly connected to an approved chimney or vent,
- 31 3. if electrically powered, properly connected to an electric circuit of adequate power,
- 32 4. if a hot-air type, equipped with proper seals between sections of the furnace to prevent fumes
33 from escaping into heat ducts,

- 1 5. provided with all safety devices required by law, and
- 2 6. connected to ducts, pipes, or tubes that are free from leaks and obstructions.

3 **602.7 Space-heating units.** A space-heating unit:

- 4 1. may not use gasoline or any similar highly flammable liquid fuel,

5 **Exception:** A kerosene space heater with fuel piped from an approved tank.

- 7 2. if fuel-burning, may not be a portable unit,
- 8 3. if fuel-burning, must be properly connected to an approved flue or vent,

9 **Exception:** Ornamental gas logs are permitted in a dwelling with a proper heating
10 system if located in a vented fireplace and not in a room used for sleeping.

- 11 4. must be located to prevent and protect against overheating adjacent combustible material,
- 12 5. if using electricity, must be properly connected to an electric circuit of adequate power,
- 13 6. must be provided with all automatic and safety devices required by law,
- 14 7. may only be installed under a permit, and
- 15 8. must be properly operated.

16 **Section 603 Mechanical Equipment**

17 **603.1 General.** All mechanical equipment provided must be properly installed and maintained in a
18 safe condition. In addition, all required mechanical equipment must be maintained in a safe working
19 condition and must be capable of performing its intended function.

20 **603.2 to 603.6** *{As in IPMC}*

21 **Section 604 Electrical Facilities**

22 **604.1 Facilities required.** *{As in IPMC}*

23 **604.2 Service.** The size and usage of appliances and equipment serves as a basis for determining the
24 need for additional facilities in accordance with the National Electrical Code. Dwelling units must
25 be served by a three-wire, 120/240 volt, single-phase electrical service having a rating of not less
26 than 60 amperes.

27 **604.3 Electrical system defects.** Inadequate service, improper fusing, insufficient receptacle or
28 lighting outlets, improper wiring or installation, deterioration, damage, and similar defects in an
29 electrical system must be corrected.

30 **604.3.1 Abatement of hazards associated with water.** *{Not Adopted}*

31 **604.3.2 Abatement of hazards associated with fire.** *{Not Adopted}*

32 **Section 605 Electrical Equipment**

33 **605.1 Installation.** *{As in IPMC}*

1 **605.2 Receptacles.** Every habitable space in a dwelling must contain at least 2 separate and remote
2 duplex outlets. Every kitchen area must contain additional outlets, connected to an appropriate
3 circuit, for a stove and for a refrigerator. Every laundry area must contain at least 1 grounded-type
4 receptacle or a receptacle with a ground fault circuit interrupter. Every bathroom must contain at
5 least 1 dual-receptacle. Any new bathroom receptacle outlet must have ground fault circuit
6 interrupter protection.

7 **605.3 Luminaires.** *{As in IPMC}*

8 **605.4 Halls and stairs.** In a multiple-family dwelling, every common hallway and stairway must be
9 adequately lighted at all times with at least 3 foot candles of light at the floor or stair tread level.
10 Other dwellings must have facilities sufficient to provide this level of illumination and be equipped
11 with conveniently located light switches to turn the facilities on and off as needed.

12 **Section 606 Elevators, Escalators, and Dumbwaiters** *{As in IPMC}*

13 **Section 607 Duct Systems** *{As in IPMC}*

14 Chapter 7. Fire Safety Requirements

15 **Section 701 General**

16 **701.1 Scope.** *{As in IPMC}*

17 **701.2 Responsibility.** Except as provided in § 704 {"PROTECTION AND DETECTION SYSTEMS"} OF
18 THIS CHAPTER, the owner and operator of the premises must provide and maintain fire safety
19 facilities and equipment in compliance with these requirements.

20 **Section 702 Means of Egress** *{As in IPMC}*

21 **Section 703 Fire-Resistance Ratings**

22 **703.1 Fire-resistance-rated assemblies.** The required fire-resistance rating must be maintained for
23 all fire-resistance-rated walls, fire stops, occupancy separations, shaft enclosures, furnace room
24 enclosures, stairwell enclosures, partitions, and floors.

25 **703.2 Opening protectives.** Required opening protectives must be maintained in an operative
26 condition.

27 **703.2.1 Fire and smokestop doors.** All fire and smokestop doors:

- 28 1. must be maintained in an operative condition,
- 29 2. may not be blocked, obstructed, or otherwise made inoperable, and
- 30 3. must be equipped with approved self-closing devices.

31 **Section 704 Protection and Detection Systems**

32 **704.1 General.** Fire alarm and [detections] DETECTION systems must comply with the requirements
33 of Fire Code § 907 {"FIRE ALARM AND DETECTION SYSTEMS"}.

34 **704.1.1 Automatic sprinkler systems.** *{As in IPMC}*

2 **704.5 Carbon monoxide alarms.** Carbon monoxide alarms must be installed and maintained in
3 accordance with Building Code § 1211 {"CARBON MONOXIDE ALARMS"}.

4 **Chapter 8. Referenced Standards** 5 *{AS IN IPMC}*

6 **[Section 801 General]**

7 **[801.1 Scope.** This Chapter 8 lists the standards that are referred to in various sections of this Code.
8 The standards are listed by the promulgating entity, the standard identification, the effective date and
9 title, and the section(s) of this Code that refer to the standard. The application of these standards is
10 as specified in § 102.7 of this Code.]

11 **[801.2 City modifications.** The following substitutions should be made in the standards listed:

17 **§ 8-101. City adoption.**

18 (a) *In general.*

19 The International Fire Code [(2009 Edition)] (2012 EDITION) is adopted as part of the
20 Building, Fire, and Related Codes of Baltimore City, subject to the additions, deletions,
21 amendments, and other modifications contained in this Part VIII.

22 (b) *Codification.*

23 Unless otherwise specified, chapter and section numbers in this Part VIII refer to the
24 chapter and section numbers of the International Fire Code.

25 **§ 8-102. City modifications.**

26 The additions, deletions, amendments, and other modifications adopted by the City are as
27 follows:

28 **Chapter 1. SCOPE AND Administration**

29 **Section 101 General**

30 **101.1 Title.** [These] THE regulations CONTAINED IN THIS CODE constitute and are known as the
31 "BALTIMORE CITY Fire Code [of Baltimore City]".

27 **Section 103 Department of Fire Prevention {Not Adopted }**

28 **Section 104 General Authority And Responsibilities**

29 **104.1 General. {As in IFC}**

30 **104.1.1 Legal enforcement.** The Fire Code Official may institute or cause to be instituted, at
31 any time, any and all legal, equitable, or criminal actions or proceedings necessary or appropriate
32 to enforce this Code. Nothing in this Code prevents the Fire Code Official from instituting or

1 causing to be instituted and fully prosecuting any and all legal or equitable proceedings of any
2 kind necessary or appropriate to compel compliance with this Code, even if criminal proceedings
3 are pending or have been completed.

4 **104.2 to 104.9** *{As in IFC}*

5 **104.10 Fire investigations.** *{As in IFC}*

6 **104.10.1 Fire Investigation Bureau; Fire Marshal.** The Fire Investigation Bureau is
7 continued in the Fire Department. The Bureau consists of members assigned to it by the Chief
8 of the Fire Department. The head of the Bureau is the Fire Marshal of Baltimore City, to be
9 designated by the Chief. The Chief may also designate one or more officers or officials to
10 serve in the absence of the Fire Marshal.

11 **104.10.2 General duties.** The Fire Investigation Bureau investigates fires and related incidents
12 in Baltimore City. The Bureau must keep a complete record of these fires and related incidents,
13 including their cause and origin, and a complete record of its investigations. The Assistant Chief
14 or his or her designee is the custodian of all records of investigations. In addition to the duties
15 specified in this section, the Bureau performs all other duties assigned to it by law or by the
16 Chief of the Fire Department.

17 **104.10.3 Charge of evidence.** In investigating a fire or related incident, the Bureau must take
18 charge immediately of the physical evidence and, to preserve that evidence, take measures to
19 prevent access by any person to the structure or premises until the evidence has been properly
20 processed.

21 **104.10.3.1 Cooperation with other agencies.** The Bureau must notify the persons
22 designated by law to pursue investigations, cooperate with authorities in collecting evidence
23 and in prosecuting offenders, and pursue the investigation to its conclusion.

24 **104.10.3.2 Assistance from other agencies.** Police and other enforcement agencies are
25 authorized to render assistance in the investigation of fires when requested to do so.

26 **104.10.4 Authority of Fire Marshal.** The Fire Marshal has general supervision and control of
27 all fire investigations in the City and of all inquiries to determine their cause and origin, both for
28 the purpose of eliminating that cause and, if arson or incendiaries is suspected, to ascertain the
29 persons responsible.

30 **104.10.5 Penalty for obstructing investigation.** Any person who prevents or obstructs or
31 attempts to prevent or obstruct an investigation is guilty of a misdemeanor and, on conviction, is
32 subject to the penalties specified in § 109 {"VIOLATIONS"} of this Code.

33 **104.10.6 Subpoena of witness and documents.** In conducting an investigation, the Fire
34 Marshal may subpoena and compel attendance of any person and the production of any
35 documents that, in the judgment of the Fire Marshal, are connected with and necessary to the
36 investigation, and have that person examined on oath or affirmation at the time and place
37 specified in the subpoena. Officers of the Baltimore Police Department may serve the subpoena.

38 **104.10.7 Enforcement of subpoena.** If a person is served with a subpoena and fails to attend
39 and testify, or fails on examination to answer any question, or otherwise fails to comply with the
40 subpoena, the Fire Marshal may apply to a judge of the Circuit Court of Baltimore City to order
41 compliance to the subpoena. If the judge orders compliance, the Fire Marshal must so notify the
42 person named in the subpoena and fix the time and place for his or her further examination. If
43 the person still fails to comply, the person may be arrested and charged with contempt.

1 **104.10.8 Administration of oaths.** The Fire Marshal may administer oaths or affirmations.
2 Any false testimony given under oath or affirmation administered by the Fire Marshal, if material
3 and made willfully, is punishable as perjury.

5 reasonably evident in a case, the Fire Marshal must submit all of the Bureau's records on the
6 case to the State's Attorney of Baltimore City.

9 annually review a fee schedule for non-fire suppression services performed by the Fire Department.

16 must be paid before the permit is issued. An issued permit must be kept on the premises
17 designated in that permit at all times and must be readily available for inspection by the Fire
18 Code Official.

3 **106.1 Inspection authority. {As in IFC}**

7 **106.5 Right of entry.** Whenever necessary to enforce this Code or whenever the Fire Code Official
8 has reasonable cause to believe that, in any structure or on an premises, a condition exists that makes
9 the structure or premises unsafe, the Fire Code official may enter to inspect the structure or premises
10 or to perform any duty imposed on the Fire Code Official by this Code.

11 **106.5.1 Occupied premises.** If the structure or premises is occupied, the Fire Code Official
12 must first present proper credentials and request entry. If entry is refused, the Fire Code Official
13 has the same authority to secure a search warrant as that vested in the Building Official by
14 § 104.6 {"RIGHT OF ENTRY"} of the Baltimore City Building Code.

15 **Section 107 Maintenance {As in IFC}**

16 **Section 108 Appeals**

17 **108.1 Appeals to Board of Fire Commissioners.** Any person who is aggrieved by any notice,
18 decision, order, or determination of the Fire Code Official may appeal in writing to the Board of Fire
19 Commissioners. The appeal must be filed with the Board within 30 days after the notice, decision,
20 order, or determination is served.

21 **108.2 Affect of appeal.** An appeal filed within 5 days of service stays all proceedings on the notice,
22 decision, order, or determination appealed from. An appeal filed later does not stay any proceedings;
23 however, on application of the person taking the appeal and notice to the Fire Code Official, the
24 Board may grant a restraining order for good cause shown.

25 **108.3 Hearing.** Within 10 days after the appeal is filed, the Board must grant a hearing to the
26 appellant. All interested parties have a right to be heard at the hearing.

27 **108.4 Board decision.** Within 10 days after the hearing concludes, the Board must render its
28 decision. In its decision, the Board may reverse, affirm, or modify the notice, decision, order, or
29 regulation appealed from and may give or make any other notice, decision, order, requirement, or
30 determination that ought to be made under the circumstances. To that end, the Board has all the
31 powers that are conferred on the Fire Code Official by this Code. However, the Board does not have
32 any authority to waive, set aside, or in any way change any specific provision of this Code.

33 **108.5 Appeals from Board.** A party aggrieved by a Board decision made under § 108.4 OF THIS
34 CODE may seek judicial review of that decision by petition to the Circuit Court for Baltimore City in
35 accordance with the Maryland Rules of Procedure. A party to the judicial review may appeal the
36 court's final judgment to the Court of Special Appeals in accordance with the Maryland Rules of
37 Procedure. A judicial review or appeal does not stay any criminal or equitable proceedings on the
38 decision appealed from, nor does it prevent the Fire Code Official or any other City official from
39 pursuing any other action or enforcement procedure authorized by law.

2 been served, the Fire Code Official may not take any action, except in the case of imminent danger,

20 of not more than \$1,000 or imprisoned for not more than 10 days or both. Each day that a violation
21 continues after service of notice is a separate offense.
